

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations, which further amend the National Insurance (Overlapping Benefits) Regulations (Northern Ireland) 1961, provide for certain cases in which the earnings-related supplements to unemployment benefit, sickness benefit and widow's allowance introduced by the National Insurance (No. 2) Act (Northern Ireland) 1966 are not to be adjusted by reference to other benefits. They also further amend the National Insurance (Hospital In-Patients) Regulations (Northern Ireland) 1961 so as to secure that those regulations shall not apply to the earnings-related supplements.

SUPERANNUATION

Reckoning of Teaching Service

REGULATIONS, DATED 22ND AUGUST 1966, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 8(2) OF THE SUPERANNUATION ACT (NORTHERN IRELAND) 1947.

The Ministry of Finance, in exercise of the powers conferred on it by section 8(2) of the Superannuation Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1. These Regulations may be cited as the Superannuation (Reckoning of Teaching Service) (Amendment) Regulations (Northern Ireland) 1966.

2. Regulation 4 of the Superannuation (Reckoning of Teaching Service) Regulations (Northern Ireland) 1949(b) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These amending regulations affect persons in the Civil Service who transferred from teaching service in Great Britain before 1st April 1950 and whose combined service is reckonable for superannuation purposes under section 8 of the Superannuation Act (Northern Ireland) 1947. Under the existing regulations a slight reduction is made in the Civil Service retiring lump sum to take account of the lower lump sum under the Teachers' Scheme. The reduction is now being discontinued so that the arrangements will be more in line with modern interchange practice.

SUPERANNUATION**Joint Service**

REGULATIONS, DATED 22ND AUGUST 1966, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 3 OF THE SUPERANNUATION ACT (NORTHERN IRELAND) 1925.

The Ministry of Finance, in exercise of the powers conferred on it by section 3 of the Superannuation Act (Northern Ireland) 1925(a), and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1. These Regulations may be cited as the Superannuation (Joint Service) (Amendment) Regulations (Northern Ireland) 1966.

2. Proviso (d) to Regulation 4 of the Superannuation (Joint Service) Regulations (Northern Ireland) 1937(b) is hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

The existing regulations provide for a slight reduction in the Civil Service retiring lump sum in the case of persons with transferred Northern Ireland teaching service to take account of the lower lump sum under the Teachers' Scheme in respect of service up to a certain date. The reduction is now being discontinued so that the arrangements will be more in line with modern interchange practice.
