

## EXPLANATORY NOTE

*(This note is not part of the Regulations but is intended to indicate their general purport.)*

These Regulations define the maternity medical services to be provided by medical practitioners under arrangements made by health authorities in pursuance of Section 38(2)(b) of the Health Services Act (Northern Ireland) 1948.

Inter alia, the Regulations—

- (a) prescribe terms of service for practitioners providing maternity medical services;
- (b) provide for the maintenance by each health authority of an obstetric list of the practitioners under contract to provide maternity medical services in their area;
- (c) provide for the establishment of an Obstetric Committee which will determine the conditions governing admission to and continued inclusion in the obstetric lists and will have certain other functions in relation to these lists.

## STOCK TRANSFER

## Recognition of Stock Exchanges

ORDER, DATED 20TH OCTOBER 1966, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 4 OF THE STOCK TRANSFER ACT (NORTHERN IRELAND) 1963.

The Ministry of Finance, in exercise of the powers conferred on it by Section 4 of the Stock Transfer Act (Northern Ireland) 1963(a), and of all other powers enabling it in that behalf, hereby makes the following Order:—

1. Each of the stock exchanges specified in the Schedule hereto is hereby declared to be a recognised stock exchange for the purposes of the Stock Transfer Act (Northern Ireland) 1963.

2. The Stock Transfer (Recognition of Stock Exchanges) Order (Northern Ireland) 1965(b) is hereby revoked.

3. This Order may be cited as the Stock Transfer (Recognition of Stock Exchanges) Order (Northern Ireland) 1966 and shall come into operation on 24th October 1966.

## EXPLANATORY NOTE

*(This Note is not part of the Order, but is intended to indicate its general purport.)*

This Order, which supersedes the Stock Transfer (Recognition of Stock Exchanges) Order (Northern Ireland) 1965, declares certain stock exchanges to be recognised stock exchanges for the purposes of the Stock Transfer Act (Northern Ireland) 1963. The Act prescribes two forms of transfer for registered securities. These are the Stock Transfer which is for general use and the Brokers Transfer which is for use in conjunction with a Stock Transfer where securities sold on the Belfast Stock Exchange or one of the stock exchanges recognised by Order of the Ministry of Finance and bought on one of those exchanges are to be transferred to more than one person. In the latter case a single Stock Transfer form executed by the transferor is supplemented by a separate Brokers Transfer for each transferee completed by the brokers for both parties in the transaction.

## NATIONAL INSURANCE

**Modification of the Royal Ulster Constabulary Pensions Provisions**

REGULATIONS, DATED 4TH OCTOBER 1966, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION 103(1) OF THE NATIONAL INSURANCE ACT (NORTHERN IRELAND) 1966.

Whereas the Ministry of Finance has determined under section 103(1) of the National Insurance Act (Northern Ireland) 1966(a) that the Minister of Home Affairs is the appropriate Minister to make regulations under that section modifying the scheme for the provision of pensions and other benefits established under the Constabulary and Police (Ireland) Act 1919(b), the Constabulary Act (Northern Ireland) 1922(c) and the Constabulary (Pensions) Act (Northern Ireland) 1949(d):

Now, therefore, I, the Right Honourable Robert William Brian McConnell, Minister of Home Affairs, in exercise of the powers conferred on me by the said section 103(1) and of all other powers enabling me in that behalf, hereby make the following Regulations:—
