# General Dental Services—Scale of Fees

REGULATIONS, DATED 8TH FEBRUARY, 1966, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND) 1948.

The Ministry of Health and Social Services in exercise of the powers conferred on it by Section 11 of the Health Services Act (Northern Ireland)

1948(a) and of all other powers enabling it in that behalf, and in conjunction with the Ministry of Finance for Northern Ireland, hereby makes the following regulations:—

- 1. These regulations may be cited as the Health Services (General Dental Services) (Scale of Fees) Regulations (Northern Ireland) 1966.
- 2. The Health Services (General Dental Services) Regulations (Northern Ireland) 1964(b) shall be amended as follows:—
- (1) In paragraph 3 of Part I of Schedule 6 there shall be added after "1965" the words "and before the 1st January, 1966".
- (2) In Part I of Schedule 6 there shall be added the following paragraph:
  - "4.—(1) Subject to the following provisions of this paragraph the Board shall pay to a dental practitioner in addition to the fees authorised under Regulation 18 a sum equal to 5 per cent. of the amount of those fees.
  - (2) This paragraph shall apply only to dental estimate forms received by the Committee on or after 21st January, 1966 and which are in respect of general dental services provided under a contract or arrangement entered into or made on or after 1st January, 1966.
  - (3) Dental estimate forms received by the Committee prior to 21st January, 1966 and which are in respect of general dental services provided under a contract or arrangement entered into or made on or after 1st January, 1966 shall be increased by a sum equal to 2.7 per cent. of the amount of the fees authorised under Regulation 18."

# EXPLANATORY NOTE

(This Note is not part of the Regulations but is intended to indicate their general purport.)

These regulations amend the Health Services (General Dental Services) Regulations (Northern Ireland) 1964 by providing that the existing additional payment of 2.7 per cent. will cease from 1st January, 1966, and that additional payments equal to 5 per cent. of the fees payable to general dental practitioners shall be made in respect of treatment given under contracts or arrangements entered into or made on or after 1st January, 1966.
