NATIONAL INSURANCE (INDUSTRIAL INJURIES)**Benefit**

REGULATIONS, DATED 1ST APRIL, 1966, MADE BY THE INDUSTRIAL INJURIES JOINT AUTHORITY UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACT (NORTHERN IRELAND) 1946.

The Industrial Injuries Joint Authority, in exercise of powers conferred by section 12(2)(d) and (3) and section 15(1) of the National Insurance (Industrial Injuries) Act (Northern Ireland) 1946(a) and of all other powers enabling them in that behalf, hereby make the following regulations:

(a) 1946. c. 21.

Citation and commencement

1. These regulations, which may be cited as the National Insurance (Industrial Injuries) (Benefit) Amendment Regulations (Northern Ireland) 1966, shall be read as one with the National Insurance (Industrial Injuries) (Benefit) Regulations (Northern Ireland) 1948(a) (hereinafter referred to as "the principal regulations") and shall come into operation on 6th April, 1966.

Amendment of regulation 6 of the principal regulations

2.—(1) Regulation 6 of the principal regulations (increase of disablement pension for constant attendance) shall be amended in accordance with the following paragraphs.

(2) For sub-paragraph (a) there shall be substituted the following sub-paragraph:

"(a) where the beneficiary (not being a case to which paragraph (b) relates) is to a substantial extent dependent on such attendance for the necessities of life and is likely to remain so dependent for a prolonged period, be 55 shillings (unless the attendance so required is part time only, in which case the amount shall be such lesser sum as may be reasonable in the circumstances), or, where the extent of such attendance required is greater by reason of the beneficiary's exceptionally severe disablement, a sum not exceeding 82 shillings and 6 pence;"

(3) In sub-paragraph (b) of the said regulation 6 after the words "where the beneficiary is so" there shall be inserted the word "exceptionally".

Amendment of Schedule 1 to the principal regulations

3.—(1) The following item shall be inserted after item 6 of Schedule 1 to the principal regulations:

"6A. Forequarter or hindquarter amputation 100"

(2) For item 24 of the said Schedule there shall be substituted the following item:

"24. Amputation below hip and above knee with stump exceeding 5 inches in length measured from tip of great trochanter, or at knee not resulting in end bearing stump 70"

(3) For item 25 of the said Schedule there shall be substituted the following item:

"25. Amputation at knee resulting in end bearing stump or below knee with stump not exceeding 3½ inches 60"

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the National Insurance (Industrial Injuries) (Benefit) Regulations (Northern Ireland) 1948 so as to give effect in Northern Ireland to those recommendations of the Committee on the Assessment of Disablement (Cmnd. 2847) relating to the scheduled degrees of disablement and the provision of a new rate of constant attendance allowance where the need for such attendance is greater because of exceptionally severe disablement.

POISONS

REGULATIONS, DATED 6TH APRIL, 1966, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION 32 OF THE MEDICINES, PHARMACY AND POISONS ACT (NORTHERN IRELAND) 1945.

I, the Right Honourable Robert William Brian McConnell, Minister of Home Affairs for Northern Ireland, in exercise of the powers vested in me by Section 32 of the Medicines, Pharmacy and Poisons Act (Northern Ireland) 1945(a) on the recommendation of the Poisons Board do hereby make the following Regulations:—

Citation and Commencement

1. These Regulations may be cited as the Poisons Regulations (Northern Ireland) 1966 and shall come into operation on 1st May, 1966.

Amendments

2. For Paragraph (2) of Regulation 33 of the Poisons Regulations (Northern Ireland) 1965(b) there shall be substituted the following paragraph, that is to say:

“(2) In all establishments in which poisons for the treatment of human ailments are sold by way of wholesale dealing and wherein the breaking of bulk, or repacking and relabelling of the poisons takes place, the department in which the poisons are stored must be in the charge of a person holding any of the qualifications set out in the foregoing paragraph (1) and this person must supervise the labelling of all poisons sold or supplied.”
