

(2) Any such Order may be made so as to apply either generally to any railway or to any specified section or part of a railway in Northern Ireland or to any specified traffic or kind of traffic (being the carriage of passengers or of goods or of both).

(3) If any person in respect of any traffic so prohibited acts in contravention of any such Order he shall be liable to imprisonment for a term not exceeding six months or to a fine not exceeding £100 or to both such imprisonment and fine.

(4) In this Regulation "specified" means specified in an Order made under this Regulation".

2. These Regulations may be cited as the Civil Authorities (Special Powers) Acts (Amending) Regulations (Northern Ireland) 1966.

Extinguishment of Public Rights of Way

REGULATIONS, DATED 18TH APRIL, 1966, MADE BY THE MINISTRY OF DEVELOPMENT UNDER THE NEW TOWNS ACT (NORTHERN IRELAND) 1965.

The Ministry of Development, in exercise of the powers conferred upon it by sections 25 and 43 of the New Towns Act (Northern Ireland) 1965(a), and of all other powers enabling it in that behalf, hereby makes the following regulations:—

Citation

1. These regulations may be cited as the New Towns (Extinguishment of Public Rights of Way) Regulations (Northern Ireland) 1966.

Publication of Notice

2. When an order is made by a new town commission under section 25 of the New Towns Act (Northern Ireland) 1965 for the extinguishment of a public right of way the new town commission shall cause to be published in one or more than one newspaper circulating in the area a notice in the form set out in the Schedule.

NEW TOWNS ACT (NORTHERN IRELAND) 1965

EXTINGUISHMENT OF PUBLIC RIGHT OF WAY

Notice is hereby given that the (1)
 in pursuance of their powers under the New Towns Act (Northern Ireland) 1965,
 on the (2) day of 19 , made an Order,
 which will be submitted to the Ministry of Development for approval, ordering
 that the public right of way described in the Schedule be extinguished.

A copy of the said Order and of the map referred to therein may be inspected
 at (3) at all reasonable hours.

The Act provides that the Order shall not have effect until approved by the
 said Ministry and that an Order to which any objection is made and not with-
 drawn shall not be approved until a public local inquiry is held into the matter.

Any objection to the Order must be made in writing, stating the grounds
 of objection, and addressed to The Secretary, Ministry of Development, Stormont,
 Belfast, 4, before the (4) day of 19 .
