

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations supersede the Regulations of 1930 and make provision for the control of vehicular traffic at modern light signals. The new provisions are as follows:—

1. Regulation 3(3) prescribes the light signals to be provided at automatic half-barrier level crossings.
2. Regulation 4 prescribes the manner in which a lens showing a green arrow may be used in light signals.
3. Regulation 5 deals with the use of portable light signals. The two-light system of signals, namely red and green, is legalised only until the 31st December 1969.
4. Regulation 6 prescribes the legal significance of the various traffic-light signals.

An obsolete provision in the 1930 Regulations for the control of pedestrians by vehicular light signals has not been re-enacted.

SUPERANNUATION

**The Superannuation (Children's Pensions) (Earnings Limit) Order
(Northern Ireland) 1967**

ORDER, DATED 3RD MAY 1967, MADE BY THE MINISTRY OF FINANCE UNDER PARAGRAPH 18 OF SCHEDULE 1 TO THE SUPERANNUATION (AMENDMENT) ACT (NORTHERN IRELAND) 1966.

The Ministry of Finance, in exercise of the powers conferred on it by paragraph 18 of Schedule 1 to the Superannuation (Amendment) Act (Northern Ireland) 1966(a), and of all other powers enabling it in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Superannuation (Children's Pensions) (Earnings Limit) Order (Northern Ireland) 1967 and shall come into operation on 15th May 1967.

Increase in earnings limit for person over 16 years of age who is undergoing training

2.—(1) The sum of £13 mentioned in section 42(1)(c)(ii) of the Superannuation Act (Northern Ireland) 1949(b) (which excludes from the definition of "period of childhood and full-time education" a person over 16 years of age who is undergoing training if the emoluments payable by his employer are

more than £13 a year) and the sum of £13 mentioned in section 9(1)(c)(ii) of the Judicial Pensions Act (Northern Ireland) 1951(a), in section 125(1)(c)(ii) of the County Courts Act (Northern Ireland) 1959(b) and in section 7(1)(c)(ii) of the Resident Magistrates' Pensions Act (Northern Ireland) 1960(c) (which contain corresponding provisions) are each hereby increased to £104.

(2) This Order does not authorise the payment, or increase, of any instalment of a pension in respect of a period falling before the date when this Order takes effect.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

Subject to certain conditions, section 42 of the Superannuation Act (Northern Ireland) 1949 permits the payment of a children's pension to continue after age 16 if the child is undergoing training for a trade, profession or vocation. One of the conditions is that the emoluments received during training, excluding the return of any premiums, do not exceed £13 a year. The same condition is attached to children's pensions under the Judicial Pensions Act (Northern Ireland) 1951, the County Courts Act (Northern Ireland) 1959 and the Resident Magistrates' Pensions Act (Northern Ireland) 1960.

This Order increases the limit on emoluments under these four Acts from £13 to £104 a year.
