Agricultural Development

SCHEME, DATED 24TH MAY 1967, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 6 OF THE AGRICULTURE ACT (NORTHERN IRELAND) 1949.

The Ministry of Agriculture in exercise of the powers conferred on it by section 6 of the Agriculture Act (Northern Ireland) 1949(a) and of every other power enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following Scheme:—

Short Title and Commencement

1. This Scheme may be cited as the Agricultural Development (Amendment) Scheme (Northern Ireland) 1967, and shall come into operation on 24th May 1967.

Amendment of 1961 Scheme

- 2.—(1) Article 2(1) of the Agricultural Development (Amendment) Scheme (Northern Ireland) 1966(b) (which amended Article 24 of the Agricultural Development Scheme 1961(c)) is hereby revoked, and accordingly the said Article 24 shall have effect as originally enacted.
- (2) The following new article shall be added to the Agricultural Development Scheme 1961 after Article 24 thereof:
 - "24A. Whereas by virtue of section 30 of the Agriculture Act 1967(d) passed by the Parliament of the United Kingdom, the person or persons carrying out certain improvements to their lands in Northern Ireland set forth in the Fourth Schedule to the said Act may become entitled to grants representing one-quarter of the approved cost thereof out of moneys provided by that Parliament, it is hereby provided that in any case where such grants have been approved for payment under the said Act for any works specified in the Fourth Schedule hereto, the Ministry may make an additional grant amounting to one-sixth of the cost of such works as finally approved to the person or persons entitled thereto as aforesaid."
- (3) In the heading to the Fourth Schedule to the Agricultural Development Scheme 1961 (as added by the Agricultural Development (Amendment) Scheme (Northern Ireland) 1966) for the words "Appropriation Act 1966" there shall be substituted "Agriculture Act 1967".

EXPLANATORY NOTE

(This Note is not part of the Scheme, but is intended to indicate its general purport.)

This Scheme amends the Agricultural Development Scheme 1961 by providing for an additional grant of one-sixth to be paid for certain farm improvement works which qualify for a grant of one-quarter under the Agriculture Act 1967 and revokes the provision made in the Agricultural Development (Amendment) Scheme (Northern Ireland) 1966 for the payment of a grant of one-sixth in addition to grant of one-quarter paid under the authority of the Appropriation Act 1966.

Physical Training (Clothing)

REGULATIONS, DATED 26TH MAY 1967, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1966.

The Ministry of Education, in pursuance of the powers vested in it by Sub-Section (3) of Section 49 of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Physical Training (Clothing) Regulations (Northern Ireland) 1967.
- 2. The Physical Training (Clothing) Regulations (Northern Ireland) 1948(b) are hereby revoked.
- 3. A local education authority may provide for pupils in attendance at primary, intermediate or special schools such articles of clothing suitable for the physical training provided at the school as are prescribed in the Schedule hereto.
- 4. Articles of clothing so provided shall remain the property of the local education authority who may allow them to be used by such of the pupils as require their use from time to time.
