## Prohibition of Sale or Export of Horned Cattle

ORDER, DATED 31ST JULY 1967, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 20 OF THE AGRICULTURE (MISCELLANEOUS PROVISIONS) ACT (NORTHERN IRELAND) 1965.

Whereas it is provided by Section 20(3) of the Agriculture (Miscellaneous Provisions) Act (Northern Ireland) 1965(a) that the Ministry of Agriculture (hereinafter referred to as "the Ministry") may by order made subject to negative resolution exempt from the provision of the said Section cattle of such classes or descriptions as may be specified.

Now therefore the Ministry in exercise of the power conferred on it by Section 20(3) of the said Act hereby makes the following Order:—

1. This Order may be cited as the Horned Cattle (Exemptions) Order (Northern Ireland) 1967.

#### Interpretation

2. In this Order:

"approved" means approved by the Ministry.

"animal" means a bovine animal.

"herd" means a herd of one animal or more.

#### Exemption from Dehorning

- 3. The following classes of cattle shall be exempted from the provisions of Section 20 of the Agriculture (Miscellaneous Provisions) Act (Northern Ireland) 1965 (which comes into force on 1st February 1969):—
  - (a) Any animal born on or before 1st day of March 1965.
  - (b) Any bull which is either entered, accepted for entry or eligible for entry in the herd book of the breed concerned and in respect of which a licence has been granted by the Ministry in accordance with the provisions of the Live Stock Breeding Act (Northern Ireland) 1922(b) as amended by the Agriculture (Miscellaneous Provisions) Act (Northern Ireland) 1960(c) and the Live Stock Breeding (Licensing of Bulls) Rules (Northern Ireland) 1963 and 1965(d), and which for the time being is in force.
  - (c) Any pedigree Hereford or Charolais female animal which is entered in the herd book of the breed concerned, provided that animal is:—
    - (i) sold at an approved public sale, which is for the sale of pedigree breeding stock,
    - (ii) sold at an approved sale for the dispersal of a herd of pedigree
    - (iii) sold privately off the farm for breeding purposes,

- (iv) from a pedigree herd and is sold for immediate slaughter by the purchaser under and in accordance with a certificate granted by the Ministry in that behalf,
- (v) exported for breeding purposes under and in accordance with a certificate granted by the Ministry in that behalf.

### Exemption Certificates

- 4.—(1) For the purposes of this Order the Ministry may issue exemption certificates, which shall be in such form as the Ministry may determine.
- (2) Application for exemption certificates under sub-paragraphs (c)(iv) and (v) of paragraph 3 shall be made to the Ministry by the herd owner at least two weeks before the animal is due to be sold from the herd, except that in the case of diseased or injured animals the Ministry may at its discretion accept an application at any time before the sale of the animal.

#### EXPLANATORY NOTE

This Order provides for the exemption from dehorning of pedigree licensed bulls and in certain circumstances of pedigree females of the Hereford and Charolais breeds.

# The Pharmaceutical Society of Northern Ireland

REGULATIONS, DATED 1ST AUGUST 1967, MADE BY THE COUNCIL OF THE PHARMACEUTICAL SOCIETY OF NORTHERN IRELAND, WITH THE APPROVAL OF THE MINISTER OF HOME AFFAIRS, UNDER SECTION THREE OF THE PHARMACY AND POISONS ACT (NORTHERN IRELAND) 1925 AS AMENDED BY THE PHARMACY ACT (NORTHERN IRELAND) 1967.

The Council of the Pharmaceutical Society of Northern Ireland, in exercise of the powers conferred on them by Section Three of the Pharmacy and Poisons Act (Northern Ireland) 1925(a) and of every other power enabling them on that behalf, hereby make the following regulations:—
