NEW TOWNS

Designation Order

ORDER*, DATED 22ND AUGUST 1967, MADE BY THE MINISTER OF DEVELOPMENT, WITH THE CONCURRENCE OF THE MINISTER OF FINANCE, UNDER SECTION 1 OF THE NEW TOWNS ACT (NORTHERN IRELAND) 1965.

I, the Right Honourable William Kennedy Fitzsimmons, Minister of Development, with the concurrence of the Minister of Finance, in exercise of the powers conferred upon me by section 1 of the New Towns Act (Northern Ireland) 1965(a) and of all other powers enabling me in that behalf, hereby make the following Order:—

Citation

1. This Order may be cited as the New Town (Antrim and Ballymena) Designation Order (Northern Ireland) 1967; and this Order and the New Town (Antrim) Designation Order (Northern Ireland) 1966(b) (hereinafter referred to as “the 1966 Order”) may be cited together as the New Town (Antrim and Ballymena) Designation Orders (Northern Ireland) 1966 and 1967.

2. In the 1966 Order—

(1) the following Article shall be inserted after Article 2:—

“2A. The area of land comprising the Borough of Ballymena and the Rural District of Ballymena (hereinafter called “the additional designated area”), and shown surrounded by a thick black line on the map marked “New Town (Antrim and Ballymena) Designation Order (Northern Ireland) 1967, Map No. 1”, and signed by me is hereby designated as the site of a new town.”

(2) the following Article shall be inserted after Article 3:—

“3A. The portions of the additional designated area described in Schedule A and shown surrounded by a thick black line on the map marked “New Town (Antrim and Ballymena) Designation Order (Northern Ireland) 1967, Map No. 2” and signed by me are hereby distinguished as land that the Ministry of Development proposes to acquire for the purposes of the Act.”

(3) the following Schedule shall be inserted after the Schedule:—

“SCHEDULE A

The portions of the additional designated area distinguished under article 3A are situate in and comprise all or part of the following townlands or borough:—

Portion A Townlands of Ballee, Ballycreggay, Ballygarvey, Ballykeel, Ballykennedy, Ballylesson, Ballyloughan, Ballymarlagh, Bottom, Brocklamont, Broughshane Lower, Broughshane Upper, Caherty, Carniny, Crebilly, Drumfane, Dunclug, Galgorm, Galgorm Parks, Lisnafillon and Tullaghgarley and Borough of Ballymena

Portion B Townlands of Cardonagh, Cullybackey and Dreen

Portion C Townlands of Carmacmoin, Gloonan, Killane and Lismurnaghan

Portion D Townlands of Broughshane Upper, Kinbally, Knockboy and Tullymore

each of which said portions is more particularly shown within the inner edge of a thick black line on the map marked "New Town (Antrim and Ballymena) Designation Order (Northern Ireland) 1967, Map No. 2" and signed by the Minister."

EXPLANATORY NOTE

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order designates the Borough of Ballymena and the Rural District of Ballymena as an additional designated area to be associated with the area already designated under the New Town (Antrim) Designation Order (Northern Ireland) 1966.

This will apply the powers of the New Towns Act to the development of Ballymena and will enable development functions in both Antrim and Ballymena to be exercised by a single Development Commission.

The Order also distinguishes certain lands in the additional designated area as lands which the Ministry of Development proposes to acquire for the purposes of the Act.
