

## SCHEDULE

1. Land held by a public body not being land held by that body for the purposes of their statutory functions.
2. Land held by the Ministry of Education subject to the trusts of a scheme approved under the Educational Endowments (Ireland) Act 1885(a).

## EXPLANATORY NOTE

*(This Note is not part of the Regulations but is intended to indicate their general purport.)*

The Regulations prescribe the description of land held by public bodies which may be the subject of a development value application and of a claim for compensation by public bodies under the Land Development Values (Compensation) Act (Northern Ireland) 1965.

## SUMMARY JURISDICTION

## Petty Sessions Districts and Times

ORDER, DATED 14TH SEPTEMBER 1967, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 21(3) OF THE MAGISTRATES' COURTS ACT (NORTHERN IRELAND) 1964.

The Ministry of Home Affairs in exercise of the powers conferred on it by section 21(3)(e) of the Magistrates' Courts Act (Northern Ireland) 1964(b) and after consultation with the County Court Judge and the Resident Magistrate concerned, hereby orders and directs as follows:—

*Citation*

1. This Order may be cited as the Petty Sessions Districts and Times (Dunmurry) Order (Northern Ireland) 1967.

*Place for holding Dunmurry Petty Sessions*

2. As and from the 4th day of October 1967, Petty Sessions for the Petty Sessions District of Dunmurry shall be held in the Presbyterian Church Hall, Dunmurry, in the said Petty Sessions District.

*Revocations*

3. The Petty Sessions Districts and Times (Dunmurry) Order (Northern Ireland) 1966 dated 5th December 1966 is hereby revoked(c).

## ROAD TRAFFIC

## Speed Limits

ORDER, DATED 25TH SEPTEMBER 1967, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 23(4) OF THE ROAD TRAFFIC ACT (NORTHERN IRELAND) 1955.

The Ministry of Home Affairs in exercise of the powers conferred on it by section 23(4) of the Road Traffic Act (Northern Ireland) 1955(a) (hereinafter referred to as "the Act"), and of all other powers enabling it in that behalf, hereby orders and directs as follows:—

*Citation and Commencement*

1. This Order may be cited as the Roads (Speed Limit) (No. 6) Order (Northern Ireland) 1967 and shall come into operation on 2nd October 1967.

*Restriction of Road*

2. The length of road specified in the Schedule shall be a restricted road for the purposes of section 23 of the Act.

This Order has the effect of applying a 30 m.p.h. speed limit to a 4½-mile section of the Omagh-Dromore Trunk Road, which is being realigned and widened.
