# ROYAL ULSTER CONSTABULARY

## Pensions

## Order, dated 30th October 1967, made by the Minister of Home Affairs UNDER SECTION 4 OF THE CONSTABULARY AND POLICE (IRELAND) ACT 1919, SECTION 2 OF THE CONSTABULARY ACT (NORTHERN IRELAND) 1922 AND THE CONSTABULARY (PENSIONS) ACT (NORTHERN IRELAND) 1949.

I, the Right Honourable William Craig, Minister of Home Affairs, with the concurrence of the Ministry of Finance, in exercise of the powers conferred on me by Section 4 of the Constabulary and Police (Ireland) Act 1919(a), Section 2 of the Constabulary Act (Northern Ireland) 1922(b), the Constabulary (Pensions) Act (Northern Ireland) 1949(c) and of all other powers enabling me in that behalf and after considering representations made by the Representative Bodies, do hereby order as follows:-

#### Citation and Commencement

1. This Order may be cited as the Royal Ulster Constabulary Pensions (Amending) (No. 2) Order 1967, and shall have effect from 30th October 1967.

## Amendment of the Royal Ulster Constabulary Pensions Order 1949

2. The Schedule to the Royal Ulster Constabulary Pensions Order 1949(d), as amended(e), shall be further amended as follows:----

(1) In paragraph 12(3) for the amount '112s. 6d.' there shall be substituted the amount '127s. Od.' and for the amount '80s. Od.' there shall be substituted the amount '90s. 0d.'.

(2) In paragraph 13B(4) for the amount '112s. 6d.' there shall be substituted the amount '127s. 0d.' and for the amount '80s. 0d.' there shall be substituted the amount '90s. 0d.'.

(3) In the proviso to paragraph 17(6) for the amount 'eighty shillings' there shall be substituted the amount '90s. Od.'.

(4) In paragraph 2 of Part III of Appendix III for the amount "forty shillings" there shall be substituted the amount "42s. 6d".

(5) For (a), (b) and (c) in paragraph 3 of Part III of Appendix III there shall be substituted the following:----

- "(a) in the case of a child who is the only elder or eldest child included in a family within the meaning of the Family Allowances Act (Northern Ireland) 1966(f) to a rate not exceeding 42s. 6d. a week;
  - (b) in the case of the second child so included to a rate not exceeding 39s. 6d. a week;

- (d) in the case of each subsequent child so included to a rate not exceeding 35s. Od. a week."

## EXPLANATORY NOTE

# (This note is not part of the Order but is intended to indicate its general purport)

This Order amends the provisions of the Royal Ulster Constabulary Pensions Order 1949 relating to the discretionary increases in widows' pensions and children's allowances.

Article 2 (1), (2) and (3) increases the amount by which widows' pensions may be increased in those cases in which discretionary increases are permitted, and Article 2 (4) and (5) makes similar proviso in relation to children's allowances.
