Secondary Schools: Grant Conditions

REGULATIONS, DATED 1ST DECEMBER 1967, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1966 WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter called "the Ministry"), in pursuance of the powers vested in it by Sections 104 and 112 of the Education Act (Northern Ireland) 1947(a) and Section 8 of the Education (Amendment) Act (Northern Ireland) 1966(b) and of all other powers enabling it in that behalf and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Secondary Schools (Grant Conditions) Amending Regulations (Northern Ireland) 1967, No. 2.

(2) These Regulations shall be deemed to have come into operation on 1st July 1967.

2. The existing Regulations hereby amended are the Secondary Schools (Grant Conditions) Regulations (Northern Ireland) 1965(c).

3. The following paragraph is hereby substituted for paragraph 1 of the First Schedule to the existing Regulations:—

"Salary Grant

1. Salary grant shall be payable in respect of each recognised teacher appointed to the authorised staff of a voluntary grammar school by the school authorities with the approval of the Ministry and shall be an annual rate equal to two-thirds of the amount by which the annual rate of salary (including the vice-principal's allowance, graded allowance or allowance for second master or second mistress) payable to the teacher under the Regulations exceeds the rate of £593 per annum:

Provided that in respect of any period of absence, owing to illness, in respect of which a teacher is paid half salary, the salary grant payable by the Ministry in respect of him for the period shall be half the salary grant that would normally be payable."

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations provide that the salary grant will be two-thirds of the amount by which the salary payable to a teacher on the authorised staff of a voluntary grammar school exceeds the rate of £593 per annum as from 1st July 1967.

CONSUMER PROTECTION

Safety of Toys

REGULATIONS*, DATED 15TH NOVEMBER 1967, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 1 OF THE CONSUMER PROTECTION ACT (NORTHERN IRELAND) 1965.

The Ministry of Home Affairs in exercise of the powers conferred on it by Section 1 of the Consumer Protection Act (Northern Ireland) 1965(a), and after consulting with such persons and bodies of persons as appears to it requisite, hereby makes the following Regulations:—

Commencement and Citation

1. These Regulations may be cited as the Toys (Safety) Regulations (Northern Ireland) 1967 and shall come into operation on 1st April 1968.

Interpretation

2. In these Regulations—

“the Act” means the Consumer Protection Act (Northern Ireland) 1965;

“the Ministry” means the Ministry of Home Affairs for Northern Ireland;

“toy” means a child’s plaything.

Celluloid Toys

3.—(1) A toy shall not, whether wholly or in part, be made of or impregnated with cellulose nitrate.

(2) This Regulation shall not apply to a ball of the kind used for ping-pong or table tennis.

Toxic ingredients in the paint used on Toys

4.—(1) A toy shall not have any coating of paint which contains lead, or any compound of lead, so that the proportion (by weight) of lead calculated as the element (Pb) exceeds 11,000 parts or, after 30th November 1968, 5,000 parts in 1,000,000 parts of the dry paint film.
