

## EXPLANATORY NOTE

*(This Note is not part of these Regulations, but is intended to indicate their general purport.)*

These Regulations extend the currency of Ulster Savings Certificates of the Seventh Issue for a further five years, i.e. from twenty to twenty-five years, with interest for each unit certificate at the rate of sixpence per year during the twenty-first and twenty-second years, ninepence per year during the twenty-third and twenty-fourth years and one shilling per year during the twenty-fifth year.

## PUBLIC SERVICE VEHICLES

REGULATIONS, DATED 17TH FEBRUARY 1967, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTIONS 12 AND 19 OF THE MOTOR VEHICLES (TRAFFIC AND REGULATION) ACT (NORTHERN IRELAND) 1926 AND SECTION 72 OF THE ROAD TRAFFIC ACT (NORTHERN IRELAND) 1955.

The Ministry of Home Affairs in exercise of the powers vested in it by Sections 12 and 19 of the Motor Vehicles (Traffic and Regulation) Act (Northern Ireland) 1926(a), Section 72 of the Road Traffic Act (Northern Ireland) 1955(b), and of all other powers thereunto enabling it, hereby makes the following Regulations:—

*Citation*

1. These Regulations may be cited as the Public Service Vehicles (Amendment) Regulations (Northern Ireland) 1967 and shall come into operation on 1st March 1967.

*Interpretation*

2. In these Regulations the expression "the Principal Regulations" means the Public Service Vehicles Regulations (Northern Ireland) 1965(c).

*Licensing of women to drive private-hire hackney carriages*

3. At the end of Regulation 26 of the Principal Regulations there shall be inserted the following proviso:—

"Provided that a female may be licensed to act as the driver of a public service vehicle in respect of which a licence has been issued in the form set out in Form 6(b) of the First Schedule."

*Medical Certificate*

4. The medical certificate required by the Ministry under Regulation 22 of the Principal Regulations in connection with the licensing of a driver of a public service vehicle shall be in the form set out in the First Schedule, or in such other form as the Ministry may require.

*Application forms for drivers' and conductors' licences*

5. For Forms 8 and 9 in the First Schedule to the Principal Regulations there shall be substituted the forms set out in the Second Schedule to these Regulations.

This certificate is for the confidential use of the Licensing Authority, and medical practitioners are asked to be good enough to forward it to the Licensing Officer in the stamped addressed envelope supplied for the purpose. It shall be open to inspection by the applicant at the office of the Licensing Authority.

Any person who makes any misrepresentation in connection with the application for a licence is liable to a penalty and the applicant might be so warned before the examination is made.

*(This Note is not part of the Regulations, but is intended to indicate their general purport.)*

These Regulations have the effect of allowing women to drive private-hire taxis, i.e., those hired by prior arrangement with the operators' headquarters as opposed to those which ply or stand for hire in the streets.

The Regulations also prescribe the form of medical certificate required by the Ministry in connection with applications for P.S.V. drivers' licences, and revise the application forms for drivers' and conductors' licences to require disclosure of any previous offences instead of as formerly only those committed in connection with public service vehicles.

## COUNTY COURTS ACT (NORTHERN IRELAND) 1959

## County Courts—County of Down—Division of Banbridge

ORDER, DATED 20TH FEBRUARY 1967, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION 2(2)(b) OF THE COUNTY COURTS ACT (NORTHERN IRELAND) 1959.

I, the Right Honourable William Craig, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by Section 2(2)(b) of the County Courts Act (Northern Ireland) 1959(a) do hereby order as follows:—

*Citation and commencement*

1. This Order may be cited as the County Court Place of Sittings (Banbridge Division) Order (Northern Ireland) 1967 and shall come into operation on the 23rd day of February 1967.

*Place of sittings of County Court for Banbridge Division*

2. The ordinary sittings of the county court for the division of Banbridge shall be held in the Masonic Hall, Church Square, Banbridge, during the period of repairing the Courthouse, Banbridge, at the times set out in the County Courts Times of Sittings (Co. Down) Order (Northern Ireland) 1966(b).
