# EXPLANATORY NOTE

## (This note is not part of the Regulations, but is intended to *indicate their general purport.*)

These Regulations amend the National Insurance (Determination of Claims and Questions) Regulations (Northern Ireland) 1948 so as not to prevent in certain circumstances, after the review of certain decisions involving payment or increase of benefit, a claimant from being paid a sum on account of benefit in respect of a period earlier than six months before the date on which application for the review was made.

National Insurance (No. 2) Act (Northern Ireland) 1966(a), and of all other powers enabling it in that behalf, hereby makes the following order:

## Citation and commencement

1. This order may be cited as the National Insurance, Industrial Injuries and Supplementary Benefits (Financial Adjustments) Order (Northern Ireland) 1967 and shall come into operation on 1st May 1967.

# Adjustments in respect of combined payments of benefit

2. The provisions of section 12(3) of the National Insurance (No. 2) Act (Northern Ireland) 1966 (determination of the amount, time and manner of payments by way of adjustments falling to be made out of the National Insurance Fund or the Industrial Injuries Fund either to the Ministry of Finance or into the Exchequer or into those Funds out of moneys provided by Parliament) shall apply in the cases herein specified, that is to say, in relation to adjustments in respect of—

- (a) payments of benefit out of the National Insurance Fund or the Industrial Injuries Fund; and
- (b) payments of benefit under the Supplementary Benefits &c. Act (Northern Ireland) 1966(b);

under arrangements made or adapted for combining payments referred to at (a) and (b).

# EXPLANATORY NOTE
