EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to *indicate their general purport.*)

These Regulations amend the Supplementary Benefit (Claims and Payments) Regulations (Northern Ireland) 1966 by substituting for the existing regulation 12 a new regulation which provides that, where arrangements are made for benefit under the Supplementary Benefits &c. Act (Northern Ireland) 1966 to be paid together with unemployment benefit or retirement pension, the provisions of paragraph 2(1) of Schedule 2 to the Act regarding negligible amounts shall not apply and the provisions of paragraph 2(2) of that Schedule regarding rounding to the nearest shilling shall apply to the aggregated amount of supplementary benefit and unemployment benefit or retirement pension as the case may be. The substituted regulation also makes provision for transitional cases.
