Marketing of Tomatoes

REGULATIONS, DATED 24TH JUNE 1968, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTIONS 1, 2, 7, 17, 18, 20, 26 AND 33 OF THE HORTICULTURE ACT (NORTHERN IRELAND) 1966.

The Ministry of Agriculture in exercise of the powers conferred on it by Sections 1, 2, 7, 17, 18, 20, 26 and 33 of the Horticulture Act (Northern Ireland) 1966(a) and of every other power enabling it in that behalf after consultation with such organisations as appear to be representative of interests affected by these Regulations hereby makes the following Regulations:—

Citation and Commencement

1. These Regulations may be cited as the Tomato (Grading) Regulations (Northern Ireland) 1968, and shall come into operation on 8th July 1968.

Interpretation

2. In these Regulations, unless the context otherwise requires: —

- "the Act" means the Horticulture Act (Northern Ireland) 1966;
- "package" includes any wrapper, bag, basket, pail, punnet, tray, case, carton, parcel, cask, box, crate or other receptacle;
- "diameter", in relation to a tomato, means the longest transverse diameter taken at right angles to a line running from the calyx to the blossom end;
- "label" includes any device for conveying information by written characters or other symbols and any characters or symbols stamped or otherwise placed directly on to a package, or as the case may be, the tomato and references to the affixing of a label shall be construed accordingly;
- "locular divisions", in relation to a tomato, means internal walls separating the main cells;
- "round", in relation to a tomato, means regular in shape, symmetrical in outline and reasonably spherical;
- "tomatoes" means tomatoes whether freshly gathered or stored or taken from store but does not include any dried, frozen, bottled, canned or preserved tomatoes or tomatoes intended for manufacture;
- "licence" means a valid licence issued under the Fresh Horticultural Produce (Licensing) Regulations (Northern Ireland) 1968(b).

A pplication

3. These Regulations shall apply to home-grown and imported tomatoes.

Grading and labelling of produce for sale within Northern Ireland

4. For the purposes of Section 1 of the Act grades of quality for tomatoes shall be those designated and defined in the First Schedule and for each of the grades so designated the form of a label for indicating that tomatoes in connection with which the label is used fall within that grade shall be as set out in Fart I of the Second Schedule.

Packaging of Tomatoes

5. Tomatoes consigned, sold, offered or exposed for sale in circumstances other than the circumstances mentioned in Section 7(3) of the Act shall be packaged in accordance with the provisions of the Third Schedule.

Retail sales exempt from grading requirements

6. For the purposes of Paragraph (a) of Section 2(2) of the Act the quantity of tomatoes which may be sold by retail without complying with the provisions of Regulation 4 shall be 10 kilogrammes (22 lbs.).

Labels of countries outside Northern Ireland

7. A label recognised under the law of any country outside Northern Ireland as indicating that tomatoes in connection with which it is used are of a quality not inferior to that required by these Regulations for a grade of quality designated in the First Schedule shall be treated for the purposes of Part I of the Act as if it were in the form prescribed for that grade in these Regulations.

Small consignments

8. Section 18(1)(a) of the Act shall not apply to any consignment of tomatoes sent out of Northern Ireland if the total weight of tomatoes in such consignment together with the weight of the package in which they are contained does not exceed 10 kilogrammes (22 lbs.).

Consignment out of Northern Ireland of tomatoes for manufacture

9. No tomatoes for manufacture shall be consigned out of Northern Ireland except under and in accordance with the conditions laid down in a licence.

Manner of cancellation of labels by authorised officer

10. Where, under Section 26 of the Act, an authorised officer finds any tomato

- (a) which has affixed to it a label in the form prescribed for any grade designated and defined in the First Schedule or is in a package to which such a label is affixed, but
- (b) which he has reasonable cause to believe to be of a quality inferior to the quality required for that grade,

he may cancel that label by affixing to the tomato or to the package a label in that form prescribed in Paragraph 7 of Part I of the Second Schedule which is appropriate to indicate what appears to him to be the correct grade or where it appears to him that the quality of the tomato is inferior to that required for the grade designated Class 3 in the First Schedule to indicate that fact.

SECOND SCHEDULE

Part I

Forms of Labels

1.—(1) Any label of the kind referred to in Regulation 4 shall bear the word "Tomatoes" unless the tomatoes in connection with which the label is used are clearly visible and shall also convey the following true information relating to those tomatoes:—

- (a) the grade of quality expressed by the word or numeral "Extra", "1", "2" or "3" as the case may be and as respects tomatoes which fall within Class 1, their shape expressed by the word "round" if all the tomatoes are round or by the word "oval" in any other case;
- (b) as respects tomatoes which fall within Extra Class, that one of the size ranges specified in column 1 of Part II of the First Schedule within which the diameter of every tomato falls, expressed in terms of the figures (lower figure first) or code letter shown in relation to that range in column 1, 2 or 3 of that Schedule;
- (c) as respects tomatoes which fall within Class 1 and all of which are round, that size range or consecutive pair of size ranges specified in column 1 of Part II of the First Schedule within which the diameter of every tomato falls, expressed in terms of the figures (lower or lowest figure first) or of the code letter or letters shown in relation to that size range or pair of size ranges in column 1, 2 or 3 of that Schedule;
- (d) in any other case of tomatoes which fall within Class 1—
 - (i) that size range or consecutive pair of size ranges specified in column 1 of Part II of the First Schedule within which the diameter of every tomato falls, expressed in accordance with sub-paragraph (1)(c) of this paragraph, or
 - (ii) the size of the tomatoes expressed by the word "LARGE" if the diameter of every tomato is not less than 57 millimetres (2.25 inches) or by the word "SMALL" if the diameter of every tomato is not less than 35 millimetres (1.375 inches) but less than 57 millimetres (2.25 inches).

(2) Any such label may also convey true information as to the size of the tomatoes in connection with which it is used and which fall within Class 2 or Class 3, either by one of the means described in sub-paragraph (1)(d) of this paragraph for tomatoes falling within Class 1 or by showing the diameter of the tomato with the shortest diameter followed by the diameter of the tomato with the longest diameter, both expressed in millimetres or inches.

(3) Any reference to a label in paragraphs 2 to 6 of this Schedule is a reference to a label of a kind referred to in Regulation 4.

2. The label shall cover an area measuring not less than 40 square centimetres (6.2 square inches) and not more than 80 square centimetres (12.4 square inches) and shall be clearly distinguishable from its surroundings, either by being bounded by lines or being of a markedly contrasting colour or material or in some other respect.

3. The information referred to in paragraph 1(1)(a) shall appear in a space measuring not less than 2.5 centimetres (1 inch) in height and 3.5 centimetres (1.4 inches) in width. In the case of tomatoes which fall within Class 1, the description "round" or "oval" shall appear below the figure "1". To the right of, and contiguous with, that space there shall be a second space similar in height to the first and not less than 4.0 centimetres (1.6 inches) in width shall be left blank unless it is necessary to amend or further amend the information as to the grade conveyed in the first mentioned space. In such an event, there shall be inserted in that second space information as to the grade within which the tomatoes fall for the time being.

4. The information referred to in paragraph 1(1)(b), 1(1)(c), 1(1)(d) or 1(2) shall appear in a third space either to the right of, contiguous with and similar

in height to the second aforesaid space and not less than 2.5 centimetres (1 inch) in width, or below, contiguous with and similar in width to the first aforesaid space and not less than 3.0 centimetres (1.2 inches) in height. Each of the spaces referred to in this and the last preceding paragraph shall be rectangular in shape and bounded by lines and shall contain no information other than that specified in these paragraphs in relation to each.

5. Every letter, word or numeral appearing on a label shall be-

- (a) clearly legible;
- (b) of a dark colour upon a light coloured ground or of a light colour upon a dark coloured ground;
- (c) not less than 7 millimetres (0.28 of an inch) in height in the case of any word or numeral indicating the grade and not less than 3 millimetres (0.12 of an inch) in height in any other case.

6.—(1) In addition to the words or numerals which are necessary to convey the information specified in paragraph 1, the following words, but no others, may appear on the label as may be appropriate—"class", "minimum", "maximum" and "range".

(2) The following abbreviations, but no others, may be used on a label in place of the respective words specified in relation thereto:—

7.—(1) The label which may be affixed by an authorised officer in accordance with Regulation 10 to indicate what appears to him to be the correct grade of the tomatoes in connection with which that label is used shall be in the following form:—



The label shall be completed as follows:-

(a) by depicting at (W) a crown;

(b) by inserting at (X) the letters "M.A.N.I.";

(c) by inserting at (Y) the numeral "1", "2" or "3" as appropriate.

(2) The label which may be affixed by an authorised officer in accordance with Regulation 10 to indicate that the quality of the tomatoes in connection with which that label is used appears to him to be inferior to that required for the grade designated Class 3 in the First Schedule shall be in the following form:—



The label shall be completed by depicting at (W) a crown and by inserting at (X) the letters "M.A.N.I.".

PART II

Additional Labelling Requirements for Tomatoes consigned out of Northern Ireland

1.—(1) All tomatoes, other than for manufacture, for consignment out of Northern Ireland shall, in addition to the information specified or referred to in Part I of this Schedule, have printed on each package or on a label affixed to each package, with letters and figures 1.3 centimetres (0.5 of an inch) high the following information:—

(a) the number of the licence held by the consignor;

(b) the weight in kilogrammes or pounds of the tomatoes in the package.

(2) For the purposes of sub-paragraph (b) the abbreviations, as appropriate, specified in paragraph 6(c) of Part I of this Schedule may be used.

(3) The additional information must not be placed inside the area described in paragraph 3 of Part I of this Schedule.

THIRD SCHEDULE

Packages and Packing Material for Tomatoes other than for Manufacture

(1) Packages used for the conveyance of tomatoes shall be so constructed and of such a nature as to be capable of conveying the tomatoes from the consignor to the consignee without damage to the tomatoes.

(2) All packages and packing materials shall be clean and free from odours likely to affect the flavour of the tomatoes.

(3) Tomatoes shall be so packed as to prevent undue movement or damage to the tomatoes and soft packing material may be used.

(4) Tomatoes in any package shall be so packed that any which are exposed to view or which would be exposed to view if the package were opened in the ordinary manner, fairly represents in size, maturity and condition the entire contents of the package.

EXPLANATORY NOTE

(This Note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations prescribe-

- (1) the grades of quality for tomatoes;
- (2) the forms of labels to be used with the various grades;
- (3) the standard of packaging;
- (4) the maximum weight of tomatoes which may be sold by retail and the maximum weight of tomatoes, including packaging, which may be consigned out of Northern Ireland without complying with the grading, labelling, packaging and licensing requirements.
