Teachers' Salaries and Allowances

REGULATIONS, DATED 26TH JUNE 1968, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968.

The Ministry of Education, in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Teachers' Salaries Amending Regulations (Northern Ireland) 1968.

(2) These Regulations shall come into operation on 1st August 1968.

2. The existing Regulations hereby amended are the Teachers' Salaries Regulations (Northern Ireland) 1967(b).

3. For the table in Schedule V to the existing Regulations relating to the entitlement for secondary schools in respect of graded allowances there shall be substituted the following table:—
