## LOCAL GOVERNMENT SUPERANNUATION

REGULATIONS\*, DATED 4TH JULY 1968, MADE BY THE MINISTRY OF DEVELOPMENT, UNDER SECTION 2 OF THE LOCAL GOVERNMENT (SUPERANNUATION) ACT (NORTHERN IRELAND) 1950.

The Ministry of Development in exercise of the powers conferred on it by section 2 of the Local Government (Superannuation) Act (Northern Ireland) 1950(a), and of all other powers enabling it in that behalf, hereby makes the following regulations in the terms of a draft which has been approved by the Ministry of Finance in accordance with section 7(2) of the said Act:—

1. These regulations may be cited as the Local Government (Superannuation) (Amendment) Regulations (Northern Ireland) 1968 and shall come into operation on 4th July 1968.

2. Regulation 4(2) of the Local Government (Superannuation) Regulations (Northern Ireland) 1962(b) shall be amended as follows:—

(1) The word “or” at the end of sub-paragraph (g) shall be omitted and inserted at the end of sub-paragraph (h).

(2) After sub-paragraph (h) there shall be inserted the following sub-paragraph:—

“(i) any person who is required as a member of the staff of the New University of Ulster to participate in a superannuation scheme operated under the Federated Superannuation System for Universities.”

## EXPLANATORY NOTE

*(This note is not part of the regulations, but is intended to indicate their general purport.)*

These regulations exclude certain staff of the New University of Ulster who are required to participate in the superannuation scheme operated under the Federated Superannuation System for Universities from any application of the Local Government (Superannuation) Regulations (Northern Ireland) 1962 to the staff of the New University by virtue of any designation made under section 8(1) of the Local Government (Superannuation) Act (Northern Ireland) 1950.
