**FAMILY ALLOWANCES, NATIONAL INSURANCE  
AND INDUSTRIAL INJURIES**

**Commencement (No. 2) Order (Northern Ireland) 1968**

ORDER, DATED 22ND JULY 1968, MADE BY THE MINISTER OF HEALTH AND SOCIAL SERVICES UNDER THE FAMILY ALLOWANCES AND NATIONAL INSURANCE (NO. 2) ACT (NORTHERN IRELAND) 1968.

Whereas it is provided by paragraph 1 of Schedule 3 to the Family Allowances and National Insurance (No. 2) Act (Northern Ireland) 1968(a) that the provisions of section 1 of that Act shall not come into force until such date as the Minister of Health and Social Services may by order appoint:

Now, therefore, I, the Right Honourable William James Morgan, Minister of Health and Social Services, hereby make the following order:

1. The date appointed for the coming into force of any provision of the Family Allowances and National Insurance (No. 2) Act (Northern Ireland) 1968 specified in column 1 of the Schedule, so far as that provision relates to any subject matter specified in column 2 of that Schedule, shall be the date specified in column 3 thereof in relation to that subject matter.

2. This order may be cited as the Family Allowances, National Insurance and Industrial Injuries (Commencement) (No. 2) Order (Northern Ireland) 1968.
