## FOYLE FISHERIES

## Foyle Area (Dealers' Registers) Regulations 1968

REGULATIONS, DATED 16TH JULY 1968, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE AND FISHERIES IN THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISHERIES ACT 1952 AND OF THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission hereinafter referred to as "the Commission" in exercise of its powers under Section 13 of the Foyle Fisheries Act 1952, Section 13 of the Foyle Fisheries Act (Northern Ireland) 1952, Section 163 of the Fisheries (Consolidation) Act 1959, and Section 120 of the Fisheries Act (Northern Ireland) 1966, hereby makes the following regulations:—

1. These regulations may be cited as the Foyle Area (Dealers' Registers) Regulations 1968, and shall come into force on the first day of September 1968.

2. In these regulations:—

the expression "authorised person" has the same meaning as in Section 112(6) of the Fisheries Act (Northern Ireland) 1966,

the expression "Foyle Area" has the meaning given to it by Section 3 of the Foyle Fisheries Act 1952 and Section 3 of the Foyle Fisheries Act (Northern Ireland) 1952,

the expression "inspector" has the meaning given to it by Section 154(c) of the Fisheries (Consolidation) Act 1959.

3. The Register to be kept by licence holders in accordance with Part X of the Fisheries (Consolidation) Act 1959 and Section 114 of the Fisheries (Northern Ireland) Act 1966 shall be in the form specified in the Schedule hereto and shall be maintained in duplicate.

4. Every licence holder or persons keeping the register shall, on demand by an authorised person or inspector, surrender the duplicate copies of all entries which have been made in a register.
