**NATIONAL INSURANCE (INDUSTRIAL INJURIES)****Insurable and Excepted Employments**

REGULATIONS, DATED 1ST NOVEMBER 1968, MADE BY THE INDUSTRIAL INJURIES JOINT AUTHORITY, WITH THE CONSENT OF THE MINISTRY OF FINANCE, AND THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER THE NATIONAL INSURANCE (INDUSTRIAL INJURIES) ACT (NORTHERN IRELAND) 1966.

The Industrial Injuries Joint Authority, with the consent of the Ministry of Finance, so far as relates to matters with regard to which such consent is required, in exercise of powers conferred by Part III of Schedule 1 to the National Insurance (Industrial Injuries) Act (Northern Ireland) 1966(a), and the Ministry of Health and Social Services, in exercise of powers conferred by section 74(1) of that Act, and of all other powers enabling them in that behalf, hereby make the following regulations:

*Citation and commencement*

1. These regulations, which may be cited as the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Amendment Regulations (Northern Ireland) 1968, shall be read as one with the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Regulations (Northern Ireland) 1948(b) (hereinafter referred to as "the principal regulations") and shall come into operation on 4th November 1968.

*Amendment of Part I of Schedule 2 to the principal regulations*

2.—(1) Part I of Schedule 2 to the principal regulations (which Part sets out employments which are to be included among the insurable employments) shall be amended in accordance with paragraph (2).

(2) Immediately after paragraph 2 there shall be added—

"3. Employment as an office cleaner or in any similar capacity in any premises other than those used as a private dwelling house."

*Amendment of Schedule 3 to the principal regulations*

3.—(1) Schedule 3 to the principal regulations (employments in respect of which persons are treated as employers) shall be amended in accordance with paragraph (2).

(2) Immediately after paragraph 2 there shall be added—

(a) in the first column:

"3. Employment as an office cleaner or in any similar capacity in any premises other than those used as a private dwelling house."; and

(b) in the second column:

"3. (a) Where the person employed is supplied by, or through the agency of, some third person and receives his remuneration from, or through the agency of that third person, that third person;

(b) in any other case, the person with whom the person employed contracted to do the work."

#### EXPLANATORY NOTE

*(This note is not part of the regulations, but is intended to  
indicate their general purport.)*

These regulations amend the National Insurance (Industrial Injuries) (Insurable and Excepted Employments) Regulations (Northern Ireland) 1948, by including among the insurable employments under the National Insurance (Industrial Injuries) Act (Northern Ireland) 1966 employment as an office cleaner or in any similar capacity in any premises other than those used as a private dwelling house, and by prescribing the persons to be treated as the employers of such persons.
