SUPERANNUATION

ORDER IN COUNCIL, DATED 26TH FEBRUARY 1968, MADE UNDER SECTION 33(1)(f) OF THE SUPERANNUATION ACT (NORTHERN IRELAND) 1967.

By the Governor in the Privy Council of Northern Ireland

ERSKINE OF RERRICK

Whereas by section 33(1)(f) of the Superannuation Act (Northern Ireland) 1967(a) the Governor of Northern Ireland is empowered to designate by Order in Council a class of employment as pensionable employment for the purposes of that section where the Ministry of Finance is satisfied that the employment entitles a person therein employed to superannuation benefits substantially similar to those conferred by or under that Act:

And whereas the Ministry of Finance is satisfied that the employment mentioned in the Schedule entitles a person therein employed to superannuation benefits substantially similar to those conferred by or under that Act:

Now, therefore, I, John Maxwell, Baron Erskine of Rerrick, Knight Grand Cross of the Most Excellent Order of the British Empire, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me as aforesaid do hereby order as follows:—

- 1. The employment mentioned in the Schedule is hereby designated pensionable employment for the purposes of section 33(1)(f) of the Superannuation Act (Northern Ireland) 1967.
- 2. This Order may be cited as the Superannuation (Designated Employment) Order (Northern Ireland) 1968 and shall come into operation on the 1st day of March 1968.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

Sections 33 and 34 of the Superannuation Act (Northern Ireland) 1967 make provision for the making of rules to preserve continuity of pension rights where pensionable staff transfer between the Civil Service and certain classes of other employment. This Order designates employment by any of the agricultural research organisations set out in the Schedule to the Order which is pensionable under the scheme administered by the Agricultural Research Council for members of its Clerical and Technical Staff or under a similar scheme administered by one of the other organisations, as a class of employment for the purposes of the sections mentioned.
