FOYLE FISHERIES**Foyle Area (Rivers Finn and Foyle) (Close Season for Angling) Regulations 1968**

REGULATIONS, DATED 24TH JANUARY 1968, MADE BY THE FOYLE FISHERIES COMMISSION WITH THE APPROVAL OF THE MINISTER FOR AGRICULTURE AND FISHERIES IN THE IRISH REPUBLIC UNDER SECTION 13 OF THE FOYLE FISHERIES ACT 1952 AND OF THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION 13 OF THE FOYLE FISHERIES ACT (NORTHERN IRELAND) 1952.

The Foyle Fisheries Commission in exercise of its powers under Section 13 of the Foyle Fisheries Act, 1952, and Section 13 of the Foyle Fisheries Act (Northern Ireland) 1952, hereby makes the following regulations:—

1. These regulations may be cited as the Foyle Area (Rivers Finn and Foyle) (Close Season for Angling) Regulations 1968, and shall come into force on the 1st day of March 1968.

2. The annual close season for angling in the waters of the River Foyle, and of the River Finn, its lakes and tributaries, shall be from the sixteenth day of September in any year to the thirteenth day of March in the year following both days inclusive.

3. The annual close season for angling in the waters of the River Foyle current at the date hereof shall terminate on the thirteenth day of March 1968.

4. The Foyle Area (Rivers Finn and Foyle) (Close Season for Angling) Regulations 1965(a) are hereby revoked.

EXPLANATORY NOTE

(This note is not part of the Regulations and does not purport to be a legal interpretation.)

The effect of these regulations is to alter the angling season on the River Foyle so as to make it the same as that for the River Finn System—i.e. from March 14th-September 15th inclusive. These regulations do not apply to tributaries of the River Foyle including the Rivers Deele and Dennett.
