#### **EDUCATION**

#### Parliamentary Grants in aid of Expenses of Local Education Authorities

REGULATIONS, DATED 27TH MARCH 1968, MADE BY THE MINISTRY OF EDUCATION UNDER SECTIONS 93, 104 AND 112 OF THE EDUCATION ACT (NORTHERN IRELAND) 1947, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education (hereinafter referred to as "the Ministry") in pursuance of the powers vested in it by Sections 93, 104 and 112 of the Education Act (Northern Ireland) 1947(a) (hereinafter referred to as "the Act") and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Parliamentary Grants (Local Education Authorities) Amending Regulations (Northern Ireland) 1968, and shall come into operation on 1st April 1968.

2. The existing Regulations hereby amended are the Parliamentary Grants (Local Education Authorities) Regulations (Northern Ireland) 1959(b).

3. Paragraph (b) of Regulation 6 of the existing Regulations shall be amended in the following respects:—

(1) For sub-paragraph (i) there shall be substituted the following paragraph: ---

"(i) salaries and other allowances payable, under any regulations of the Ministry for the time being in force, to teachers in county primary schools, county intermediate schools, county grammar schools, and in nursery schools, special schools and institutions for further education under the control of the local education authority, and to teachers employed under Section 29(3A) of the Act;".

(2) In sub-paragraph (iii) after the words "first day of April, 1948," there shall be inserted the words "and before 1st April, 1968".

(3) For sub-paragraph (v) there shall be substituted the following paragraph: --

"(v) the cost to the local education authority of employers' national insurance contributions payable in respect of teachers in county primary schools, county intermediate schools, county grammar schools and in nursery schools, special schools and institutions of further education under the control of the local education authority and in respect of teachers employed under Section 29(3A) of the Act;".

4. After Part IIIA there shall be inserted : ---

# "PART IIIB

# Grants payable under Section 104(1)(bb) of the Education Act (Northern Ireland) 1947.

7C. The grants payable to a local education authority under this Part in respect of any financial year shall be as follows:—

- (a) a grant equal to eighty per cent. of annual repayments by the local education authority in respect of the principal and interest of approved loans raised for the purposes of the Act on or after 1st April, 1968;
- (b) a grant at the rate of eighty per cent. of approved expenditure incurred on or after 1st April, 1968, where the Ministry would have consented to the local education authority borrowing money for the purpose of making contributions towards such expenditure but the local education authority for any reason decided, with the approval of the Ministry, to meet the expenditure out of revenue;
- (c) a grant at the rate of eighty per cent. of approved expenditure incurred under the provisions of Section 9(3) of the Education (Amendment) Act (Northern Ireland) 1968 on the external maintenance of maintained schools."
- 5. In Regulation 11 after Part IIIA there shall be inserted "Part IIIB".
