**Voluntary Primary, Intermediate and Special Schools Building Grant
Amending Regulations**

REGULATIONS, DATED 27TH MARCH 1968, MADE BY THE MINISTRY OF EDUCATION WITH THE APPROVAL OF THE MINISTRY OF FINANCE UNDER SECTIONS 106 AND 112 OF THE EDUCATION ACT (NORTHERN IRELAND) 1947.

The Ministry of Education in exercise of the powers conferred upon it by sections 106(1) and 112(1) of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Voluntary Primary, Intermediate and Special Schools Building Grant Amending Regulations (Northern Ireland) 1968.

(2) These Regulations shall come into operation on 1st April 1968.

2. The existing Regulations hereby amended are the Voluntary Primary, Intermediate and Special Schools Building Grant Regulations (Northern Ireland) 1964(b).

3. The following proviso shall be added to Regulation 6(4) of the existing Regulations:—

“Provided that, if and so long as the school is a maintained school, this paragraph shall not apply so as to require the applicants to perform any duties which a local education authority is required to perform in respect of the said school.”

4. For Regulation 6(5) of the existing Regulations there shall be substituted the following:—

“(5) The premises or the furniture, fittings or equipment thereof shall not be used otherwise than for the purposes of the Education Act (Northern Ireland) 1947, or the Youth Welfare, Physical Training and Recreation Acts (Northern Ireland) 1938 to 1962(c), or purposes ancillary thereto.”

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

The purpose of these Regulations is to relieve the trustees or managers of maintained schools who have received building grant from the Ministry from the obligation to perform any duties in connection with internal and external maintenance of the school premises which it is the duty of a local education authority to perform.
