Compensation for Loss of Office

REGULATIONS, DATED 6TH JUNE 1969, MADE BY THE MINISTRY OF AGRICULTURE WITH THE APPROVAL OF THE MINISTRY OF FINANCE UNDER SECTION 36 OF THE FISHERIES ACT (NORTHERN IRELAND) 1966 AS AMENDED BY SECTION 5(1) OF THE FISHERIES (AMENDMENT) ACT (NORTHERN IRELAND) 1968.

The Ministry of Agriculture in exercise of the powers conferred on it by Section 36 of the Fisheries Act (Northern Ireland) 1966(a) as amended by Section 5(1) of the Fisheries (Amendment) Act (Northern Ireland) 1968(b) and of every other power enabling it in that behalf with the approval of the Ministry of Finance hereby makes the following Regulations:—

- 1. These Regulations may be cited as the District Boards of Conservators (Compensation) Regulations (Northern Ireland) 1969.
- 2. Subject to these Regulations, compensation payable under Section 36 of the said Act of 1966 to any person shall take the form of a lump sum calculated as follows:—
 - (a) Subject to paragraph (b) in respect of each year of permanent employment with a district board of conservators completed by such person there shall be paid one-twentieth of the remuneration paid to that person by such board in respect of the period of 12 months immediately preceding the dissolution of such district board.
 - (b) For the purposes of such calculation the total number of years of such permanent employment actually completed by such person shall be increased by three.
- 3. No compensation shall be payable to any person unless he produces to the satisfaction of the Fisheries Conservancy Board for Northern Ireland such evidence verified in such manner as the Board may reasonably require with respect to any matter which would affect his entitlement to such compensation including, without prejudice to the generality of the foregoing:—
 - (a) the nature of his employment with a district board;
 - (b) the number of years he was permanently employed by the district board;
 - (c) the terms of his employment by the district board;
 - (d) the amount of remuneration he received from such district board in respect of the period of 12 months immediately preceding the dissolution of said board.
- 4. In these Regulations "remuneration" means wages or salary but does not include any payment made in respect of any expenses.

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations prescribe the manner in which the compensation which is payable by the Fisheries Conservancy Board for Northern Ireland to displaced employees of the former district boards of fishery conservators is to be calculated and the terms and conditions on which it is payable.

The Regulations provide for the payment of compensation, subject to evidence of the length and conditions of employment by the district boards. For each complete year of permanent employment one-twentieth of the remuneration for the last twelve months of employment is payable and for the purpose of this calculation, the length of service is increased by a notional figure of three years.

EDUCATION

Colleges of Education (Grant Conditions)

REGULATIONS, DATED 18TH JUNE 1969, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968.

The Ministry of Education, in pursuance of the powers vested in it by Sections 59 and 112 of the Education Act (Northern Ireland) 1947(a), and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

- 1.—(1) These Regulations may be cited as the Colleges of Education (Grant Conditions) Amending Regulations (Northern Ireland) 1969.
- (2) These Regulations shall come into operation on 1st September 1969.
- 2. The existing Regulations hereby amended are the Training Colleges (Grant Conditions) Regulations 1956(b).
- 3. For sub-paragraph (c) of Regulation 13(8) of the existing Regulations there shall be substituted the following sub-paragraph:—
 - "(c) the college premises shall not be used for political purposes, or for the transaction of any political business or for any purpose connected directly or indirectly with parliamentary or local government elections otherwise than as polling booths on the requisition of the officer responsible under the enactments governing such elections: provided that this sub-paragraph shall not prevent the holding on the premises of meetings of college societies in accordance with arrangements approved by the governors of the college; and".

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the existing conditions governing grants to voluntary colleges of education so as to ensure that the prohibition of the use of college premises for political purposes does not prevent meetings of college societies which may concern themselves with political matters.
