### **MOTOR VEHICLES (INTERNATIONAL CIRCULATION)**

REGULATIONS, DATED 30TH JUNE 1969, MADE BY THE MINISTRY OF DEVELOPMENT UNDER THE VEHICLES (EXCISE) ACT (NORTHERN IRELAND) 1954(a) AND THE MOTOR VEHICLES (INTERNATIONAL CIRCULATION) (REGISTRATION AND LICENSING) (NORTHERN IRELAND) ORDERS 1955(b) AND 1962(c).

The Ministry of Development for Northern Ireland in exercise of the powers conferred upon it by the Vehicles (Excise) Act (Northern Ireland) 1954 and the Motor Vehicles (International Circulation) (Registration and Licensing) (Northern Ireland) Orders 1955 and 1962, and every other power thereunto enabling it hereby makes the following Regulations:---

1. These Regulations may be cited as the Motor Vehicles (International Circulation) (Registration and Licensing) (Amendment) Regulations (Northern Ireland) 1969, and shall come into operation on the 1st July 1969.

2. The Motor Vehicles (International Circulation) (Registration and Licensing) Regulations (Northern Ireland) 1963(d) shall have effect as though:-

- (1) Regulation 1 (which relates to exemption from excise duty, etc. by persons bringing vehicles temporarily into Northern Ireland) were omitted:
- (2) Regulation 5 (which relates to the keeping of certain records by registration authorities) were omitted;
- (3) in Regulation 7(1) the definitions of "certificate of insurance", "certificate of security", "insurance card" and "duplicate page" were omitted;
- (4) the Schedule (which relates to particulars to be furnished to registration authorities) were omitted.

## EXPLANATORY NOTE

# (This Note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations amend the Motor Vehicles (International Circulation) (Registration and Licensing) Regulations (Northern Ireland) 1963 by:—

- 1. providing that persons resident outside the United Kingdom who bring vehicles temporarily into Northern Ireland need no longer furnish registration authorities with the particulars specified in the Schedule to the 1963 Regulations or produce to those authorities insurance documents relating to those vehicles;
- 2. terminating the need for certain records to be made by registration authorities in respect of vehicles temporarily in Northern Ireland.

#### Milk and Meals Amending Regulations

REGULATIONS, DATED 1ST JULY 1969, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968.

The Ministry of Education (hereinafter referred to as "the Ministry") in exercise of the powers conferred on it by Sections 43, 74 and 112 of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf hereby makes the following Regulations:-

#### Citation and Commencement

1.—(1) These Regulations may be cited as the Milk and Meals Amending Regulations No 2 (Northern Ireland) 1969.

(2) These Regulations shall come into operation on 1st August 1969.

#### Existing Regulations

2. The existing Regulations hereby amended are the Milk and Meals Regulations (Northern Ireland) 1955(b).

Amendment of Regulations

- 3. (a) In Regulation 15(2)(b) of the existing Regulations the words "having regard to the power given to the authority and to managers in Regulation 16 to require teachers to supervise pupils" shall be omitted.
- (b) In Regulation 16 everything after the word "service" where it first occurs shall be omitted.
