ORDER*, DATED 12TH JUNE 1969, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES, WITH THE CONSENT OF THE MINISTRY OF FINANCE, UNDER SECTION 10(1) OF THE SELECTIVE EMPLOYMENT PAYMENTS'ACT (NORTHERN IRELAND) 1966.

The Ministry of Health and Social Services, with the consent of the Ministry of Finance, in exercise of powers conferred by section 10(1) of the Selective Employment Payments Act (Northern Ireland) 1966(a), and of all other powers enabling it in that behalf, hereby makes the following order:

1.—(1) This order may be cited as the Selective Employment Payments Variation Order (Northern Ireland) 1969 and shall come into operation on 7th July 1969.

(2) In this order—

"the Act" means the Selective Employment Payments Act (Northern Ireland) 1966.

Additions to employments to which section 1 of the Act applies

2.—(1) Section 1 of the Act (which specifies employments as respects which an employer is entitled to selective employment premium) shall have effect as if to subsection (2)(a) thereof there were added the following:

"(vi) the conversion, by using machinery to remove deleterious material or by using machinery to alter the size or shape, of scrap metal to a recognised trade specification for making new metal or for use in the manufacture of chemicals; or

(vii) the production of waste paper or waste paper board in bales to a recognised trade specification for making pulp, by the use of machinery, both to remove deleterious material and to produce the

said bales; or (viii) activities by way of the manufacture from exposed film of cinemato-

(viii) activities by way of the manufacture from exposed film of cinematograph films for public exhibition; or (ix) the production of cinematograph films for public exhibition

(ix) the production of cinematograph films for public exhibition including television presentation, or

(x) industrial photoprinting, that is to say, so much of the activities falling under sub-head 2 of minimum list heading 899 (which relates to photography) as consists of the photographic reproduction of technical drawings and the production for exhibition, display or publicity, in each case for the purpose of another's business (including the purposes of a government department, a local authority or a public body) of prints of photographic enlargements."

(2) Article 2 of the Selective Employment Payments Variation Order (Northern Ireland) 1968(b) (which specifies additional employments to which section 1 applies) shall be amended by substituting for the words "slaughtering animals in a knackery or slaughter-house" the words "slaughtering animals in or from a knackery or in a slaughter-house."

EXPLANATORY NOTE

(This note is not part of the order, but is intended to indicate its general purport.)

This order adds to the employments which may be eligible for payments under section 1 of the Selective Employment Payments Act (Northern Ireland) 1966, establishments which include knackeries where most of the slaughtering of animals takes place otherwise than at the knackery, and certain activities relating to processing of scrap metal and waste paper, the production of cinematograph films and industrial photoprinting.
