**HEALTH SERVICES****General Dental Services**

REGULATIONS, DATED 23RD JULY 1969, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER THE HEALTH SERVICES ACT (NORTHERN IRELAND) 1948.

The Ministry of Health and Social Services in exercise of the powers conferred on it by Sections 11 and 80 of the Health Services Act (Northern Ireland) 1948(a) and of all other powers enabling it in that behalf, and in conjunction with the Ministry of Finance, hereby makes the following regulations:—

*Citation*

1. These regulations may be cited as the Health Services (General Dental Services) (Amendment No. 2) Regulations (Northern Ireland) 1969.

*Effective Date*

2. These regulations shall have effect with respect to the provision of general dental services where the contract or arrangement in pursuance of which the service is provided is made on or after 11th August 1969.

*Amendment*

3. The Health Services (General Dental Services) Regulations (Northern Ireland) 1964(b) shall be amended as follows:—

- (1) In regulation 14(2) for the charge “£5.0.0.” there shall be substituted the charge “£6.5.0.”
- (2) For Schedule 7 (which prescribes the charges payable for dental appliances and dental treatment) there shall be substituted the following schedule:—

2. The amount of the charge for any dental treatment not being			
(a) the supply, replacement or repair of dentures or dental bridges;			
(b) the repair of orthodontic appliances, obturators, splints, radium applicators or other special dental appliances;			
(c) the arrest of bleeding; or			
(d) the clinical examination of a patient or any report thereon;			
shall be the current authorised fee for all such services or thirty shillings whichever is the less.			
3. The charge shall in no case exceed £6 5s. 0d.”

These regulations further amend the Health Services (General Dental Services) Regulations (Northern Ireland) 1964 by providing for increases in the authorised charges for the supply of dentures and the maximum charge for a course of treatment including the provision of dentures.
