# Judges' Salaries

ORDER IN COUNCIL, DATED 29TH OCTOBER 1969, MADE UNDER SECTION 106(1A) OF THE COUNTY COURTS ACT (NORTHERN IRELAND) 1959.

By the Governor in the Privy Council of Northern Ireland

#### GREY OF NAUNTON

Whereas by Section 106(1A) of the County Courts Act (Northern Ireland) 1959(a) it is provided that an Order in Council directing that the salaries of County Court Judges may be increased to such amount payable from such date, whether before or after the making of the Order, as may be specified therein, may be made by the Governor:

And whereas it is further provided by Section 106(1B) of the said Act of 1959 that the Governor shall not be recommended to make such Order until a draft thereof, which has been approved by the Ministry of Finance, has been laid before Parliament and approved by a resolution of each House of Parliament\*:

And whereas a draft of this Order has been approved by the Ministry of Finance:

Now, therefore, I, Ralph Francis Alnwick, Baron Grey of Naunton, Knight Grand Cross of the Most Distinguished Order of St. Michael and St. George, Knight Commander of the Royal Victorian Order, Officer of the Most Excellent Order of the British Empire, Governor of Northern Ireland, by and with the advice and consent of Her Majesty's Privy Council of Northern Ireland, in exercise of the powers conferred by the said section, do hereby direct as follows:—

- 1. This Order may be cited as the County Court Judges (Salaries) Order (Northern Ireland) 1969.
- 2. The County Court Judges (Salaries) Order (Northern Ireland) 1967(b) is hereby revoked.
- 3. As from the 23rd July 1969 there shall be paid to the Recorder of Belfast an annual salary of £7,050 and to every other County Court Judge an annual salary of £6,550, in lieu of the respective salaries theretofore payable to such Recorder and Judges.

## **EXPLANATORY NOTE**

(This Note is not part of the Order but is intended to indicate its general purport.)

This Order raises the salaries of the Recorder of Belfast to £7,050 per year and of the County Court Judges to £6,550 per year.
