#### Assessment of Resources

REGULATIONS, DATED 1ST OCTOBER 1969, MADE BY THE MINISTRY OF HOME AFFAIRS, WITH THE CONCURRENCE OF THE MINISTRY OF FINANCE, UNDER SECTIONS 4 AND 14 OF THE LEGAL AID AND ADVICE ACT (NORTHERN IRELAND) 1965.

The Ministry of Home Affairs, with the concurrence of the Ministry of Finance, in exercise of the powers conferred by sections 4 and 14 of the Legal Aid and Advice Act (Northern Ireland) 1965(a) and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

#### Citation and commencement

1. These Regulations may be cited as the Legal Aid (Assessment of Resources) (Amendment) Regulations (Northern Ireland) 1969 and shall come into operation on the 1st December 1969.

## Interpretation

2. In these Regulations—

"the Principal Regulations" means the Legal Aid (Assessment of Resources) Regulations (Northern Ireland) 1965(b).

Meaning of "authorised summary proceedings" in principal regulations

- 3. In Regulation 1(2) of the Principal Regulations in the definition of "authorised summary proceedings" for paragraph (c) there shall be substituted the following paragraphs:—
  - "(c) proceedings under sections 94, 95, 96, 97, 104, 108, 143 and 144(1) of the Children and Young Persons Act (Northern Ireland) 1968 and sections 38 and 38A of the Education Act (Northern Ireland) 1947; and
    - (d) proceedings specified in Regulation 3 of the Legal Aid (Extension of Proceedings) Regulations (Northern Ireland) 1969;".

# EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations amend the definition of "authorised summary proceedings" in the Legal Aid (Assessment of Resources) Regulations (Northern Ireland) 1965 (S.R. & O. No. 218) in consequence of the Children and Young Persons Act (Northern Ireland) 1968 and the extension of availability of legal aid to certain proceedings specified in the Legal Aid (Extension of Proceedings) Regulations (Northern Ireland) 1969 (S.R. & O. 1969, No. 305).
