### **ROYAL ULSTER CONSTABULARY**

#### Allowances

### ORDER, DATED 20TH NOVEMBER 1969, MADE BY THE MINISTER OF HOME AFFAIRS UNDER SECTION 4 OF THE CONSTABULARY AND POLICE (IRELAND) ACT 1919 AND SECTION 2 OF THE CONSTABULARY ACT (NORTHERN IRELAND) 1922.

I, the Right Honourable Robert Wilson Porter, Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by Section 4 of the Constabulary and Police (Ireland) Act 1919(a) and Section 2 of the Constabulary Act (Northern Ireland) 1922(b) and all other powers enabling me in that behalf, and after considering representations made by the Representative Bodies constituted by the said Act of 1919, as required by Section 4 of that Act, do hereby order as follows:—

#### Citation

1. This Order may be cited as the Royal Ulster Constabulary Allowances (Amendment) Order 1969.

#### Amendments to the Royal Ulster Constabulary (Miscellaneous) Allowances Order 1968

2. The Royal Ulster Constabulary (Miscellaneous) Allowances Order 1968(c) shall be amended as follows:—

(1) For Article 4 there shall be substituted :—

"4.—(1) Table 1 of this Article shall apply with effect as from 1st September 1968 until 31st August 1969 and table 2 with effect as from 1st September 1969, in the case of a member who is assigned for a continuous period of not less than 7 days to detective duty and, while so engaged, is in the opinion of the Inspector General usually engaged in outside duty.

(2) Subject to Article 14 such a member shall, for the period of assignment—

(a) if he holds a rank below that of District Inspector, be paid a detective duty allowance at the rate appropriate to his rank as shown

in the following tables:—

(b) if he holds a rank below that of County Inspector, be paid a detective expenses allowance at the rate appropriate to his rank as shown in the following table:—

(2) For Article 5(1) there shall be substituted: ----

"5.—(1) Subject to Article 14, where a member is assigned for a continuous period of not less than 7 days to the duty of driving an official motor-vehicle allocated to a member of the Government or the Inspector General he shall, while so assigned, be paid a special duty driver's allowance at a rate appropriate to his rank as shown in the relevant table in Article 4(2)(a)."

(3) For Article 12(1) there shall be substituted: --

"12.—(1) Subject to Article 14, a member assigned to the regular duty of driving an official motor-vehicle allocated to a member of the Government or the Inspector General or as escort to the Governor of Northern Ireland shall, while so assigned, be paid a livery allowance at the rate of  $\pounds 7$  a year."

### Amendments to the Royal Ulster Constabulary (Travelling and Removal) Allowances Order 1968

3. The Royal Ulster Constabulary (Travelling and Removal) Allowances Order 1968(d) shall be amended as follows:—

(1) In Article 10 (which relates to household removal allowances) there shall, with effect from 1st December 1968 be substituted:—

(a) In paragraph (7) for the amount of  $\pounds 10$ , the amount of  $\pounds 15$ ;

- (b) In paragraph (8):
  - (i) in sub-paragraph (a), for the amount of £50, the amount of £75;
  - (ii) in sub-paragraph (b), for the amount of £40, the amount of £60; and
  - (iii) in sub-paragraph (c), for the amount of £30, the amount of £45.
- (2) (a) In paragraph 1 of appendix 2 (which relates to mileage allowances) for the amount of 5d. there shall be substituted, with effect from 1st February 1969, the amount of  $5\frac{1}{2}d$ .
- (b) In the table in paragraph 2 of appendix 2—
  - (i) for the amount of  $8\frac{1}{4}d$ . there shall be substituted, with effect from 1st January 1969, the amount of 9d., and
  - (ii) for the amount of 5d. there shall be substituted, with effect from 1st February 1969, the amount of  $5\frac{1}{2}d$ .
- (c) In paragraph 5 of appendix 2, for the amount of  $3\frac{3}{4}d$ . there shall be substituted, with effect from 1st November 1968, the amount of 4d.

## **EXPLANATORY NOTE**

### (This note is not part of the Order but is intended to indicate its general purport.)

This Order increases the rates of detective-duty allowances and specialduty drivers' allowances payable to the relevant members of the force. The escort to His Excellency The Governor of Northern Ireland is included with those entitled to be paid a livery allowance. The Order also increases the amounts payable to a member on moving house when transferred, and the rates of mileage allowance are also increased.
