Teachers' Salaries and Allowances

REGULATIONS, DATED 11TH JUNE 1970, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968 (2.1)

The Ministry of Education in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf, and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1. These Regulations may be cited as the Teachers' Salaries Amending Regulations (Northern Ireland) 1970, No. 2, and shall be deemed to have come into operation on 1st April 1970.

2. The existing Regulations hereby amended are the Teachers' Salaries Regulations (Northern Ireland) 1969(b).

3. In Part II of Schedule II to the existing Regulations—

(a) the date "1st April 1970" shall be substituted for the date "1st April 1969" where it occurs in paragraph

(b) the following shall be substituted for paragraph 2:—

"2. If serving as a principal in a recognised school on 31st March 1970—

(a) Primary and secondary schools with a points category not exceeding 100 and special schools with a points category not exceeding 60:

At the point which falls short of the maximum by the same number of increments as the point on which he was placed on the scale applicable to him immediately prior to 1st April 1970 fell short of the maximum of that scale.

(b) All schools other than those provided for at (a):

At the point at which he was placed on the scale applicable to him immediately prior to 1st April 1970."

(c) the following shall be substituted for paragraph 7:—

"7. A principal who on 31st March 1970 was serving in a recognised school and was placed beyond the maximum of the scale applicable to him on that date shall not by reason of the operation of the scales set out in Part I of this Schedule receive a smaller rate of salary than he received on 31st March 1970, together with an addition of £120 per annum for so long as he continues as principal of the school in which he was serving on that date or of a school in a points category not below that in which he was serving on that date."

4. In Schedule IV to the existing Regulations the following shall be substituted for the Note to the Schedule:—

“Notes 1, 2 and 6 to Part I of Schedule II shall apply to this Schedule.”

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the provisions relating to the placing of principals of primary schools, secondary schools (other than technical intermediate schools) and special schools on the salary scales in connection with the new scales which became operative from 1st April 1970.
