EDUCATION**Grammar Schools (Admissions, Scholarships and Special Allowances)**

REGULATIONS, DATED 22ND JULY 1970, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968.

The Ministry of Education, in pursuance of the powers vested in it by Sections 48 and 76 of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Grammar Schools (Admissions, Scholarships and Special Allowances) Amending Regulations No. 2 (Northern Ireland) 1970.

(2) These Regulations shall come into operation on 1st August 1970.

2. The existing Regulations hereby amended are the Grammar Schools (Admissions, Scholarships and Special Allowances) Regulations 1965(b).

3. For the table in paragraph 1 of the Schedule to the existing Regulations there shall be substituted the following table:—

EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations make provision for the payment of revised rates of Maintenance Allowances in respect of qualified pupils attending grammar schools who are over the upper limit of the compulsory school age.
