**AGRICULTURE (MISCELLANEOUS PROVISIONS) ACT
(NORTHERN IRELAND) 1970****Appointed Day**

ORDER, DATED 10TH NOVEMBER 1970, MADE BY THE MINISTER OF AGRICULTURE UNDER SUB-SECTION (2) OF SECTION 14 OF THE AGRICULTURE (MISCELLANEOUS PROVISIONS) ACT (NORTHERN IRELAND) 1970.

I, the Right Honourable Phelim Robert Hugh O'Neill, Minister of Agriculture, in exercise of the powers conferred on me by Section 14(2) of the Agriculture (Miscellaneous Provisions) Act (Northern Ireland) 1970(a) and of all other powers enabling me in that behalf do hereby order as follows:—

1. This Order may be cited as the Agriculture (Miscellaneous Provisions) Act (Appointed Day) Order (Northern Ireland) 1970.

2. Section 2(1) to (6) and (8) of the Act shall come into operation on the 1st January 1971.

DISEASES OF ANIMALS**Poultry Exhibitions**

ORDER, DATED 12TH NOVEMBER 1970, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTIONS 1 AND 13 OF THE DISEASES OF ANIMALS ACT (NORTHERN IRELAND) 1958.

The Ministry of Agriculture in exercise of the powers conferred on it by Sections 1 and 13 of the Diseases of Animals Act (Northern Ireland) 1958(a) (hereinafter referred to as "the Act") and of every other power enabling it in that behalf hereby makes the following Order:—

Citation and commencement

1. This Order which may be cited as the Diseases of Animals (Restriction on Exhibition of Poultry) Order (Northern Ireland) 1970 shall come into operation on the 12th November 1970.

Amendment of the First Schedule of the Act

2. Paragraph 14 of Part II of the First Schedule of the Act shall be amended as follows:—

For the words "Section 23 of the Act" there shall be substituted—
"Sections 13 and 23 of the Act".

Prohibition on exhibition of poultry

3. No exhibition of poultry shall be organised or held by any person, show society or association of poultry breeders or fanciers.

Saving

4. Notwithstanding Article 3 the Ministry may grant a licence allowing such exhibition subject to such conditions as may be specified in the licence.

EXPLANATORY NOTE

(This note is not part of the Order but is intended to indicate its general purport.)

This Order imposes restrictions on the exhibition of poultry and applies for this purpose the definition of poultry as extended by the Diseases of Animals (Amendment of First Schedule—Poultry) Order (Northern Ireland) 1970.
