HOUSING ON FARMS**Grants in respect of Farmhouses and of approved workers houses**

ORDER*, DATED 3RD NOVEMBER 1970, MADE BY THE MINISTRY OF DEVELOPMENT WITH THE APPROVAL OF THE MINISTRY OF FINANCE, UNDER SECTION 12 OF THE HOUSING ON FARMS ACT (NORTHERN IRELAND) 1950.

The Ministry of Development (in this Order referred to as "the Ministry"), with the approval of the Ministry of Finance, in exercise of the powers conferred on the Ministry by Section 12 of the Housing on Farms Act (Northern Ireland) 1950(a) (in this Order referred to as "the Act"), and of every other power it thereunto enabling, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Housing on Farms (Grants) Order (Northern Ireland) 1970 and shall, subject to the provisions of Section 12(4) of the Act, come into operation on the 1st January 1971.

Grants for provision of new farmhouses

2. The amount of grant payable under Section 1 of the Act in respect of a new farmhouse completed before the 1st January 1973, in accordance with plans submitted to and approved by the Ministry before the 1st January 1972, and falling within any one of the categories mentioned in the first column of Schedule 1 shall be the amount specified opposite such category in the second column of the said Schedule.

Grants for provision of houses for approved workers

3. The amount of grant payable under Section 4 of the Act in respect of an approved worker's house completed before the 1st January 1973, in accordance with plans submitted to and approved by the Ministry before the 1st January 1972, and falling within any one of the categories mentioned in the first column of Schedule 2 shall be the amount specified opposite such category in the second column of the said Schedule.

Grants for reconditioned premises as farmhouses or approved workers' houses

4. The amount of grant payable under Section 7 of the Act in respect of the reconditioning of any premises for use as a farmhouse or approved worker's house completed before the 1st January 1973, in accordance with plans submitted to and approved by the Ministry before the 1st January 1972, and falling within any one of the categories mentioned in the first column of Schedule 3 shall be the amount specified opposite such category in the second column of the said Schedule.

<p>NEW HOUSES FOR APPROVED WORKERS</p> <p>Where the superficial area of the new approved worker's house exceeds 750 square feet (69.68m²) and does not exceed 1050 square feet (97.55m²).</p>	£600

Category of House	Amount of Grant payable by the Ministry
<p>Reconditioning of premises for occupation as farmhouses or approved workers' houses</p>	<p>Where the approved cost exceeds £75—</p> <p>(a) half of the approved cost; or</p> <p>(b) the sum of £1,000 whichever is the lesser.</p>

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

The object of this Order is (1) increase the rates of grant payable and (2) to extend to the 1st January 1972 the date before which plans for the provision of houses and the reconditioning of premises as houses on farms must be submitted to the Ministry of Development for approval in order to qualify for grant.

The Order also prescribes the rates of grant payable in respect of new farmhouses, approved workers' houses, and reconditioning works, and prescribes the dates before which work must be completed in order to qualify for the rates of grant specified.
