Institutions of Further Education: Teachers' Salaries and Allowances

REGULATIONS, DATED 5TH MAY 1970, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND) 1947 TO 1968.

The Ministry of Education, hereinafter referred to as "the Ministry", in pursuance of the powers vested in it by Sections 83 and 112 of the Education Act (Northern Ireland) 1947(a) and of all other powers enabling it in that behalf and after consultation with the Ministry of Finance, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Institutions of Further Education (Salaries and Allowances) Amending Regulations (Northern Ireland) 1970.

(2) Except as otherwise provided herein these Regulations shall be deemed to have come into operation on 1st September 1969.

2. The existing Regulations hereby amended are the Institutions of Further Education (Salaries and Allowances) Regulations (Northern Ireland) 1969, No. 3(b).

3. With effect from 1st April 1970 for paragraph (1) of Regulation 6 there shall be substituted the following paragraph:

"(1) Subject to the provisions of these Regulations the scale of salary for assistant lecturers shall be as follows:—

4. With effect from 1st April 1970 in paragraph (2) of Regulation 6 of the existing Regulations "£2,040" shall be substituted for "£1,920" and "£2,095" shall be substituted for "£1,975".

5. To Regulation 20 of the existing Regulations there shall be added:—

“(3) Unless the Ministry shall approve otherwise a local education authority shall

(a) appoint to any vacant senior post a teacher serving in the institution who is in receipt of a compensation allowance under the Institutions of Further Education: Teachers’ Salaries (Compensation Allowances) Regulations (Northern Ireland) 1969(c) or the Teachers’ Salaries (Compensation Allowances) Regulations (Northern Ireland) 1969(d);

(b) award an allowance to a lecturer Grade I serving in the institution who is in receipt of a compensation allowance under the Institutions of Further Education: Teachers’ Salaries (Compensation Allowances) Regulations (Northern Ireland) 1969 or the Teachers’ Salaries (Compensation Allowances) Regulations (Northern Ireland) 1969 before making such an award to any other lecturer Grade I serving in the institution.”

6. In paragraph (2) of Regulation 21 of the existing Regulations “26s. 6d.” shall be substituted for “25s. 0d.”

7. With effect from 1st April 1970 in Regulation 28 of the existing Regulations “£703” shall be substituted for “£583”.

8. With effect from 1st April 1970 for Schedule II of the existing Regulations there shall be substituted the following Schedule:—

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations introduce from 1st April 1970 revised scales of salaries for teachers in institutions of further education, and from 1st September 1969 a revised rate of allowance for evening work. They also provide that a teacher in an institution of further education who is receiving a compensation allowance shall be appointed to any vacant senior post or given preference when allowances are being awarded unless the Ministry approves otherwise.
