Importation and Planting of Potatoes

Order, dated 10th May 1971, made by the Ministry of Agriculture under the Plant Health Act (Northern Ireland) 1967.

The Ministry of Agriculture in exercise of the powers conferred on it by Section 2 of the Plant Health Act (Northern Ireland) 1967(a), and of every other power enabling it in that behalf, hereby makes the following Order:—

Citation and commencement

- 1.—(1) This Order may be cited as the Importation and Planting of Potatoes (Amendment) Order (Northern Ireland) 1971.
 - (2) This Order shall come into operation on the 10th May 1971.

Revocation

2. The Importation and Planting of Potatoes (Amendment) Order (Northern Ireland) 1968(b) and the Importation and Planting of Potatoes (Amendment) Order (Northern Ireland) 1969(c) are hereby revoked.

Amendment of Principal Order

3. There shall be substituted for the First Schedule to the Importation and Planting of Potatoes Order (Northern Ireland) 1964(d) the Schedule to this Order.

Northern Ireland Hospitals Authority Officers

REGULATIONS, DATED 11TH MAY 1971, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER SECTION 63 OF THE HEALTH SERVICES ACT (NORTHERN IRELAND) 1971.

The Ministry of Health and Social Services for Northern Ireland (hereinafter referred to as "the Ministry"), in exercise of the powers conferred on it by section 63 of the Health Services Act (Northern Ireland) 1971(a) (hereinafter referred to as "the Act"), hereby makes the following Regulations:—

Citation and interpretation

- 1.—(1) These Regulations may be cited as the Health Services (Northern Ireland Hospitals Authority Officers) Regulations (Northern Ireland) 1971.
 - (2) In these Regulations—
 - "remuneration" includes all salary, wages, fees and allowances payable to officers in respect of their employment in the Hospital Service.

Revocation

- 2. The Health Services (Northern Ireland Hospitals Authority Officers) Regulations (Northern Ireland) 1965(b) are hereby revoked.
- 3. The remuneration and conditions of service of all officers of the Authority, as determined by the Authority in accordance with the provisions of section 63(3) of the Act, shall be subject to the approval of the Ministry.

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These Regulations replace and amend the Health Services (Northern Ireland Hospitals Authority Officers) Regulations (Northern Ireland) 1965 by removing the provisions for the approval by the Ministry of the qualifications, number, appointment and dismissal of certain classes of officers of the Hospitals Authority.
