SCHEME, DATED 19TH JANUARY 1971, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTIONS 6 AND 13 OF THE AGRICULTURE ACT (NORTHERN IRELAND) 1949.

The Ministry of Agriculture in exercise of the powers conferred on it by Sections 6 and 13 of the Agriculture Act (Northern Ireland) 1949(a) and of every other power enabling it in that behalf and with the approval of the Ministry of Finance hereby makes the following Scheme:—

Short title and commencement

1. This Scheme may be cited as the Agricultural Development (Amendment) Scheme (Northern Ireland) 1971 and shall come into operation on 19th January 1971.

Amendment of Agricultural Development Scheme 1961

2.—(1) Applications for assistance towards the cost of carrying out works specified under Schedule 1 of the Agricultural Development Scheme 1961(b) as amended will not be accepted after the date of commencement of this Scheme.

(2) Claims for the payment of grant on works for which application for assistance was made to the Ministry before the coming into operation of this Scheme will not be accepted after 31st December 1973 or such later date as the Ministry may in special circumstances permit.

EXPLANATORY NOTE

(This note is not part of the Scheme but is intended to indicate its general purport.)

This Scheme amends the Agricultural Development Scheme 1961 by prohibiting the acceptance of any further applications for grants in respect of field drainage and farm water supplies, grants for which have been absorbed into the Farm Capital Grant Scheme with effect from 1st January 1971. It provides however for the payment of grants in respect of such works provided the claim is received by the Ministry of Agriculture on or before 31st December 1973.

FRIENDLY SOCIETIES**Qualifications of Actuaries**

REGULATIONS, DATED 20TH JANUARY, 1971, MADE BY THE REGISTRAR OF FRIENDLY SOCIETIES UNDER SECTIONS 100 AND 103 OF THE FRIENDLY SOCIETIES ACT (NORTHERN IRELAND) 1970.

The Registrar, in exercise of the powers conferred upon him by sections 100 and 103 of the Friendly Societies Act (Northern Ireland) 1970(a), hereby makes the following Regulations:—

Citation

1. These Regulations may be cited as the Friendly Societies (Qualifications of Actuaries) Regulations (Northern Ireland) 1971.

Qualifications of actuaries

2. A person shall be a qualified actuary for the purposes of the Friendly Societies Act (Northern Ireland) 1970 if he is either a Fellow of the Institute of Actuaries or a Fellow of the Faculty of Actuaries.

EXPLANATORY NOTE

These Regulations prescribe the qualifications which an actuary must have before he can be appointed by a friendly society or branch to value its assets and liabilities, and to certify tables in pursuance of the Friendly Societies Act (Northern Ireland) 1970.
