**LAND REGISTRATION ACT (NORTHERN IRELAND) 1970****Appointed Day**

ORDER, DATED 15TH JUNE 1971, MADE BY THE MINISTER OF FINANCE UNDER SECTION 99(3) OF THE LAND REGISTRATION ACT (NORTHERN IRELAND) 1970.

I, the Right Honourable Herbert Victor Kirk, Minister of Finance, in exercise of the powers conferred on me by Section 99(3) of the Land Registration Act (Northern Ireland) 1970(a) do hereby order as follows:—

1. This Order may be cited as the Land Registration Act (Appointed Day) Order (Northern Ireland) 1971.

2. The provisions of the Land Registration Act (Northern Ireland) 1970 specified in the Schedule shall come into operation on the 28th day of June 1971.
