Citation and commencement

1. This Order may be cited as the Miscellaneous Fees (Variation) Order (Northern Ireland) 1971 and shall come into operation on the 1st July 1971.

Variation of fees

2. The enactments specified in the second column of the Schedule (which relate to fees payable in respect of the matters mentioned in the third column of the Schedule) shall be amended by substituting for the sums specified in the fourth column of the Schedule, the sums specified in the fifth column thereof.
