## SUMMARY JURISDICTION

## Petty Sessions Districts and Times

ORDER, DATED 8TH NOVEMBER 1971, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 21(3) OF THE MAGISTRATES' COURTS ACT (NORTHERN IRELAND) 1964.

The Ministry of Home Affairs in exercise of the powers conferred on it by Section 21(3) of the Magistrates' Courts Act (Northern Ireland) 1964(a) and of all other powers enabling it in that behalf, after consultation with the County Court Judges and Resident Magistrates concerned, hereby orders and directs as follows:—

*Citation and commencement*

1. This Order may be cited as the Petty Sessions Districts and Times (No. 2) Order (Northern Ireland) 1971 and shall come into operation on the 1st day of December 1971.

*Abolition of Petty Sessions Districts of Crumlin, Templepatrick and Caledon*

2.—(1) The Petty Sessions District of Crumlin shall be added to and become part of the Petty Sessions District of Antrim, and in consequence thereof the said Petty Sessions District of Crumlin is hereby abolished.

(2) The Petty Sessions District of Templepatrick shall be added to and become part of the Petty Sessions District of Antrim with the exception of the townland of Ballygowan, which shall be added to and become part of the Petty Sessions District of Ballymena, and in consequence thereof the said Petty Sessions District of Templepatrick is hereby abolished.

(3) The townlands set forth in the Schedule, at present forming the Petty Sessions District of Caledon, shall be added to and become part of the Petty Sessions Districts of Armagh and Dungannon, as shown in the said Schedule, and in consequence thereof the said Petty Sessions District of Caledon is hereby abolished.

*Revocations*

3. The Petty Sessions Districts and Times (General) Order (Northern Ireland) 1967(b) insofar as it relates to Crumlin, Templepatrick and Caledon: the Petty Sessions Districts and Times (Crumlin) Order (Northern Ireland) 1969(c).
