RESIDENT MAGISTRATES: SALARIES AND ALLOWANCES

ORDER, DATED 26TH FEBRUARY 1971, MADE BY THE MINISTER OF HOME AFFAIRS WITH THE CONCURRENCE OF THE MINISTER OF FINANCE, UNDER SECTION 12(1) OF THE MAGISTRATES' COURTS ACT (NORTHERN IRELAND) 1964.

I, The Right Honourable James Dawson Chichester-Clark, D.L., Minister of Home Affairs for Northern Ireland, in exercise of the powers conferred on me by Section 12(1) of the Magistrates' Courts Act (Northern Ireland) 1964(a) do hereby make the following Order:—

Citation and commencement

1. This Order may be cited as the Resident Magistrates (Salaries and Allowances) Order (Northern Ireland) 1971.

Revocation

2. The Resident Magistrates (Salaries and Allowances) Order (Northern Ireland) 1969(b) is hereby revoked.

Salaries of Resident Magistrates

3.—(1) The annual salary payable to a Resident Magistrate appointed for the City of Belfast shall be £5940 as from the 1st April 1970, £6000 as from the 1st July 1970 and £6030 from the 1st January 1971.

(2) The annual salary payable to every other Resident Magistrate shall be £5690 as from the 1st April 1970, £5750 as from the 1st July 1970 and £5780 as from the 1st January 1971.

Allowances of Resident Magistrates

4. In addition to the salary specified in Article 3 a Resident Magistrate shall be paid an allowance in respect of travelling, subsistence and incidental expenses at such rate and subject to such conditions as may from time to time be fixed by the Ministry of Home Affairs with the concurrence of the Ministry of Finance.

Salaries and allowances of Deputy Resident Magistrates

5. The salary payable to a Deputy Resident Magistrate shall with effect from 1st January 1971 be at the rate of £20 for each day upon which he adjudicates, together with such allowances in respect of travelling, subsistence and incidental expenses as may from time to time be fixed by the Ministry of Home Affairs with the concurrence of the Ministry of Finance.

REGULATIONS*, DATED 2ND FEBRUARY 1971, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER THE WELFARE FOODS ACT (NORTHERN IRELAND) 1968.

The Ministry of Health and Social Services in exercise of the powers conferred upon it by section 5(2) of Welfare Foods Act (Northern Ireland) 1968(a) and of all other powers enabling it in that behalf hereby makes the following regulations—

Title and commencement

1. These regulations may be cited as the Welfare Foods (Extension of Definition) Regulations (Northern Ireland) 1971 and shall come into operation on 1st April 1971.

Addition to definition of Welfare Food

2. In the definition of "Welfare Food" in section 5(1) of the Welfare Foods Act (Northern Ireland) 1968 there shall be added the following foods—

"Vitamins A, D and C combined in liquid form".

EXPLANATORY NOTE

(This note is not part of the Regulations but is intended to indicate their general purport.)

These regulations extend the definition of Welfare Food in section 5(1) of the Welfare Foods Act (Northern Ireland) 1968 to include vitamins A, D and C combined in liquid form.
