CLEAN AIR**Smoke Control Areas—Exempted Fireplaces**

REGULATIONS, DATED 10TH MARCH 1971, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER SECTION 11(7) OF THE CLEAN AIR ACT (NORTHERN IRELAND) 1964.

The Ministry of Health and Social Services in exercise of the powers conferred upon it by Section 11(7) of the Clean Air Act (Northern Ireland) 1964(a) and of every other power enabling it in that behalf, hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Smoke Control Areas (Exempted Fireplaces) Regulations (Northern Ireland) 1971 and shall come into operation on 1st April 1971.

Exempted fireplaces

2. The class of fireplace described in column (1) of the Schedule hereto shall, subject to the conditions specified in column (2), be exempted from the provisions of Section 11 of the Clean Air Act (Northern Ireland) 1964.

SCHEDULE

(1) Class of fireplace	(2) Conditions
The fireplace known as the Triancomatic T80 and manufactured by Trianco Limited.	The fireplace shall be installed, maintained and operated so as to minimise the emission of smoke and in accordance with the manufacturer's instructions. No fuel shall be used other than selected washed coal singles.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

Section 11 of the Clean Air Act (Northern Ireland) 1964 empowers local authorities to declare the whole or any part of their district to be a smoke control area in which the emission of smoke is, generally, prohibited. These Regulations exempt the Triancomatic T80 fireplace from the provisions of that section, upon certain conditions as to proper operation.

Smoke Control Areas—Authorised Fuels

REGULATIONS, DATED 10TH MARCH 1971, MADE BY THE MINISTRY OF HEALTH AND SOCIAL SERVICES UNDER SECTION 43 OF THE CLEAN AIR ACT (NORTHERN IRELAND) 1964.

The Ministry of Health and Social Services in exercise of the powers conferred upon it by Section 43 of the Clean Air Act (Northern Ireland) 1964(a) and of every other power enabling it in that behalf, hereby makes the following regulations:—

Citation and commencement

1. These regulations may be cited as the Smoke Control Areas (Authorised Fuels) Regulations (Northern Ireland) 1971 and shall come into operation on 1st April 1971.

Authorised Fuel

2. The following fuel is hereby declared to be an authorised fuel for the purposes of the Clean Air Act (Northern Ireland) 1964:—

“Maxiglow” ovoids which have been manufactured by Cawoods Patent Fuels Limited and which—

- (a) comprise anthracite duff (as to approximately 93% of total weight) and pitch (as to the remaining weight) and
- (b) have been subjected to a mild heat treatment process.

EXPLANATORY NOTE

(This Note is not part of the Regulations, but is intended to indicate their general purport.)

Section 11 of the Clean Air Act (Northern Ireland) 1964 makes it an offence to emit smoke from a chimney of a building within a smoke control area unless it can be shown that the emission of smoke arose solely from use of an authorised fuel. These Regulations declare “Maxiglow” ovoids to be an authorised fuel.
