ORDER IN COUNCIL, DATED 3RD JANUARY 1972, MADE UNDER SECTION 12A(1)(h) OF THE TEACHERS (SUPERANNUATION) ACT (NORTHERN IRELAND) 1950.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND

GREY OF NAUNTON

WHEREAS by section 12A(1)(h) of the Teachers (Superannuation) Act (Northern Ireland) 1950(a), the Governor of Northern Ireland is empowered to designate by Order in Council a class of pensionable employment as employment for the purposes of that section where the Ministry of Education is satisfied that the employment entitles a person therein employed to superannuation benefits substantially similar to those conferred by that Act.

AND WHEREAS the Ministry of Education is satisfied that employments mentioned in the Schedule entitle a person therein employed to superannuation benefits substantially similar to those conferred by that Act.

NOW, THEREFORE, I, RALPH FRANCIS ALNWICK, BARON GREY OF NAUNTON, Knight Grand Cross of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Officer of the Most Excellent Order of the British Empire, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me as aforesaid do hereby order as follows:—

Citation

1. This Order may be cited as the Teachers Superannuation (Designated Employment) Order (Northern Ireland) 1972.
2. The employments mentioned in the Schedule are hereby designated employments for the purposes of section 12A(1)(h) of the Teachers (Superannuation) Act (Northern Ireland) 1950.

SCHEDULE

1. Employment under the Electricity Board for Northern Ireland which entitles a person so employed to participate in superannuation benefits provided under any scheme made under the Electricity (Supply) Act (Northern Ireland) 1931(b).

2. Employment under the Post Office which is pensionable under the Post Office Staff Superannuation Scheme.

EXPLANATORY NOTE

(This note is not part of the Order, but is intended to indicate its general purport.)

Sections 12A(1) and 12B(1) of the Teachers (Superannuation) Act (Northern Ireland) 1950 make provision for the making of rules to preserve continuity of pension rights where persons in pensionable employment transfer between teaching service in Northern Ireland and certain other employments. This Order designates employment with the Electricity Board for Northern Ireland and employment with the Post Office as employments for the purposes of those subsections.
