**Teachers' Superannuation (Family Benefits) (Amending) Rules  
(Northern Ireland) 1972**

RULES, DATED 23RD MAY 1972, MADE BY THE MINISTRY OF EDUCATION UNDER SECTION 11 OF THE TEACHERS (SUPERANNUATION) (AMENDMENT) ACT (NORTHERN IRELAND) 1956, AS AMENDED BY SECTION 1 OF THE TEACHERS SUPERANNUATION (AMENDMENT) ACT (NORTHERN IRELAND) 1967, WITH THE CONSENT OF THE MINISTRY OF FINANCE.

The Ministry of Education with the consent of the Ministry of Finance and after consultation with representatives of local education authorities and of teachers affected, in exercise of the powers vested in it by Section 11 of the Teachers (Superannuation) (Amendment) Act (Northern Ireland) 1956(a), as amended by Section 1 of the Teachers Superannuation (Amendment) Act (Northern Ireland) 1967(b), and of all other powers enabling it in that behalf hereby makes the following Rules:—

*Citation and commencement*

1. These Rules may be cited as the Teachers' Superannuation (Family Benefits) (Amending) Rules (Northern Ireland) 1972 and shall be deemed to have come into operation on 17th March 1972.

2. The existing Rules hereby amended are the Teachers' Superannuation (Family Benefits) Rules (Northern Ireland) 1972(c).

*Amount of widow's pension*

3. In paragraph (2) of Rule 48 of the existing Rules—

(a) the word "or" at the end of subparagraph (b) shall be omitted;

(b) in subparagraph (c) after "1st May 1971" there shall be inserted "and before 17th March 1972" and at the end of that subparagraph there shall be added—

"or

(d) £153 if her husband, on or after 17th March 1972 so ceased or so died."

*Amount of short service widow's pension*

4. In Rule 51 of the existing Rules—

(a) the word "or" at the end of paragraph (b) shall be omitted;

(b) in paragraph (c) after "1st May 1971" there shall be inserted "and before 17th March 1972" and at the end of that paragraph there shall be added—

"or

(d) in column (5) thereof in the case of a widow whose husband, on or after 17th March 1972 so ceased or so died:—"; and

(c) there shall be added to the Table as an additional column—

*Amount of children's pension*

5. In paragraph (1) of Rule 54 of the existing Rules—

(a) the word “or” at the end of subparagraph (b) shall be omitted;

(b) in subparagraph (c) after “1st May 1971” there shall be inserted “and before 17th March 1972” and at the end of that paragraph there shall be added—

“or

(d) under letter D, where such contributor or deceased teacher, on or after 17th March 1972 so ceased or so died:—” and

(c) there shall be added to columns (2) and (3) of the Table—

## EXPLANATORY NOTE

*(This note is not part of the Rules, but is intended to indicate their general purport.)*

These Rules amend the Teachers' Superannuation (Family Benefits) Rules (Northern Ireland) 1972 by raising the minimum of a widow's pension and increasing a children's and a short service widow's pension which commence after they come into operation.
