## Licence Holders' Records and Returns

REGULATIONS, DATED 10TH JULY 1972, MADE BY THE MINISTRY OF AGRI-CULTURE UNDER SECTION 17 OF THE FISHERIES ACT (NORTHERN IRELAND) 1966.

The Ministry of Agriculture, on behalf of the Secretary of State and in exercise of the powers conferred on it by Section 17 of the Fisheries Act (Northern Ireland) 1966(a) (hereinafter called "the Act") and of every other power enabling it in that behalf, hereby makes the following Regulations.

#### PART I

#### GENERAL

1. These Regulations may be cited as the Licence Holders' (Records and Returns) Regulations (Northern Ireland) 1972.

### PART II

### DEALERS' REGISTERS AND RETURNS

2. The holder of a dealer's licence issued by the Fisheries Conservancy Board for Northern Ireland under Sections 114 and 115 of the Act shall send a copy of each page of the register maintained by him under Section 120 of the Act to the Ministry of Agriculture. Such copies shall be sent to the Ministry each month and shall cover purchases, receipts and sales made during the immediately preceding month.

## PART III

## RETURNS FROM COMMERCIAL LICENCE HOLDERS

3. Every holder of a licence of a type specified in the First Schedule shall make a return to the Ministry of Agriculture of his catches of salmon, sea trout and trout.

- 4. (a) Where any person is the holder of more than one such licence he shall make a separate return in respect of each licence.
  - (b) Paragraph (a) above shall not be construed so as to demand a separate return for each box or crib in a single salmon weir.

5. The return shall be in the form shown in the Second Schedule.

6. The return shall be forwarded to reach the Ministry of Agriculture not later than 31st October in each year, in respect of catches of salmon, sea trout and trout during that year.

## FIRST SCHEDULE

- Licence for a draft net for the capture of salmon and freshwater fish on Lough Neagh.
- Licence for a draft net for use in freshwater other than Lough Neagh or Lough Erne,
- Licence for a single wall set net or trammel net for the capture of trout in Lough Neagh.

Licence for a fixed tidal draft net.

Licence for a fixed tidal draft net which operates in the estuary of a river upstream of the defined mouth.

Licence for a tidal draft net.

Licence for a drift net used in tidal waters.

Licence for a bag net used in tidal waters.

Licence for a salmon box or crib.
