## Marketing of Potatoes

REGULATIONS, DATED 3RD AUGUST 1972, MADE BY THE MINISTRY OF AGRI-CULTURE WITH THE APPROVAL OF THE MINISTRY OF FINANCE UNDER SECTIONS 3(3), 7(2) AND 11 OF THE MARKETING OF POTATOES ACT (Northern Ireland) 1964.

The Ministry of Agriculture on behalf of the Secretary of State in exercise of the powers conferred on it by sections 3(3), 7(2) and 11 of the Marketing of Potatoes Act (Northern Ireland) 1964(a) and of every other power enabling it in that behalf, and with the consent of the Ministry of Finance, hereby makes the following Regulations:—

## Citation and commencement

1. These Regulations may be cited as the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1972 and shall come into operation on the 1st day of September 1972.

Amendment of the Marketing of Potatoes Regulations (Northern Ireland) 1964

2. In paragraphs (1), (3) and (4) of Article 8 of the Marketing of Potatoes Regulations (Northern Ireland) 1964(b) as amended by the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1964(c), the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1967(d) and the Marketing of Potatoes (Amendment) Regulations (Northern Ireland) 1970(e) for the words "four shillings and six pence" there shall be substituted the words "twenty-six new pence".

# EXPLANATORY NOTE

(This note is not part of the Regulations, but is intended to indicate their general purport.)

These Regulations amend the Marketing of Potatoes Regulations (Northern Ireland) 1964.

They increase the fee payable for the inspection of potatoes under the Marketing of Potatoes Act (Northern Ireland) 1964 from four shillings and six pence (twenty-two and a half new pence) to twenty-six new pence.
