EDUCATION**Superannuation****Interchange between the Teaching Service in Northern Ireland
and certain Public Boards**

RULES, DATED 6TH JANUARY 1972, MADE BY THE MINISTRY OF EDUCATION, UNDER SECTIONS 12A AND 12B OF THE TEACHERS (SUPERANNUATION) ACT (NORTHERN IRELAND) 1950, WITH THE APPROVAL OF THE MINISTRY OF FINANCE.

The Ministry of Education in exercise of the powers conferred on it by Sections 12A and 12B of the Teachers (Superannuation) Act (Northern Ireland) 1950(a) and of all other powers enabling it in that behalf, and with the approval of the Ministry of Finance, hereby makes the following Rules:—

Citation and commencement

1. These Rules may be cited as the Superannuation (Teaching and Public Boards) Interchange (Amending) Rules (Northern Ireland) 1972, and shall come into operation on 6th January 1972.

2. These rules shall not apply to a person becoming, or ceasing to be, employed by the Electricity Board for Northern Ireland before the 1st day of January 1963.

3. The Schedule to the Superannuation (Teaching and Public Boards) Interchange Rules (Northern Ireland) 1969(b) (hereinafter called "the existing rules") shall be amended by adding thereto the following employments after employment number 5:—

"6. Employment under the Electricity Board for Northern Ireland which entitles a person so employed to participate in superannuation benefits provided under any scheme made under the Electricity (Supply) Act (Northern Ireland) 1931(c).

7. Employment under the Post Office which is pensionable under the Post Office Staff Superannuation Scheme."

4. In relation to a person becoming, or ceasing to be, employed in the employments added to the Schedule to the existing rules by these rules the operative date for the purposes of the existing rules shall be the date of the coming into operation of these rules.
