# PENSIONS (NORTHERN IRELAND) 

## Pensions Appeal Tribunals (Northern Ireland) (Amendment) Rules 1972

I, The Right Honourable Sir Robert Lynd Erskine Lowry, Lord Chief Justice of Northern Ireland, by virtue of the powers conferred on me by paragraph 5 of the Schedule to the Pensions Appeal Tribunals Act 1943(a), and of all other powers enabling me in this behalf, do hereby make the following Rules:-

1. The Pensions Appeal Tribunals (Northern Ireland) Rules 1972(b) shall be amended as follows:-
(i) In Schedule 2 Part I (which relates to subsistence allowances to appellants etc.) in paragraph $1(a)$, for the figures " $£ 0 \cdot 20$ " " $£ 0 \cdot 35$ ", and " $£ 0 \cdot 70$ ", there shall be suibstituted the figures " $£ 0 \cdot 15$ ", " $£ 0 \cdot 27 \frac{1}{2}$ " and " $£ 0 \cdot 57 \frac{1}{2}$ " respectively, and in paragraph $1(b)$, for the figure " $£ 2 \cdot 40$ " there shall be substituted the figure " $£ 1 \cdot 80$ ".
(ii) In Rule 26(3) (which relates to maximum sums payable to appellants etc. as compensation for loss of time) for the figure " $£ 4 \cdot 75$ " there shall be substituted the figure " $£ 4 \cdot 00$ ", the words "( $£ 2 \cdot 37 \frac{1}{2}$ per half-day)" shall be omitted, and "reasonable" shall be substituted for "seasonable".
(iii) In Rule 29(1) (which relates to other expenses of the Tribunal) for the figure " $£ 17 \cdot 25$ " there shall be substituted the figure " $£ 12 \cdot 60$ ".
2. These Rules may be cited as the Pensions Appeal Tribunals (Northern Ireland) (Amendment) Rules 1972 and shall come into operation on 6th December 1972.
